YOU ARE FURTHER NOTIFIED that this is an action for divorce, and, as provided by SDCL 25-4-34, this action cannot be heard, tried or determined by the Court until at least sixty (60) days have elapsed from the date of the completed service of the Plaintiff's Summons and Complaint in this action.
