As your newspaper looks to the future and toward continuing to provide the essential information that local citizens need in a timely fashion, it is appropriate to review the concept of publishing public notices in newspapers. This concept is based on two fundamental principles: First, in a democracy, the public has an absolute right to know the actions of its government. Second, a democracy is a system of checks and balances in which it is inappropriate to rely on the government to be the exclusive printer, repository and gatekeeper of information.
