ago," Dr. Allison Wierda Suttle, chief medical informatics officer for Sanford Health, said about the benefits of patients having one medical chart. "It will stop the duplication of tests. And the safety implications are huge. We'll have a medication list of what, truly, the patient is taking, instead of having to rely on Mom or Grandma saying, 'Yeah, that's what they're on.' Now we'll have a real, accurate record.'

In Faulkton, the independently run Faulkton Area Medical Center reportedly is the first small-town facility in the state to reach Stage 1 Meaningful Use criteria as determined by the Centers for Medicare & Medicaid. That successful adoption of the new technology during the past 3-1/2 years means the center will get a partial reimbursement from the federal government for its implementa-

It hasn't been easy, said Tom Hericks, director of nursing for the Faulkton center. "The time it has taken to achieve the mandates and regulations have been extremely time consuming and extremely expensive," he said. "It's been a burden, and there's no question that people have been challenged and are frustrated. Overtime, training, hardware, software, those are the costs, along with its effect on productivity.'

At the same time, Hericks said everyone understands that there is a mandate and that there is no turning back on this. DeWald said

providers receiving Medicare reimbursements have until 2015 to engage in the meaningful use of electronic records or they will lose 1 percent of those reimbursements. The penalty goes up each year without compliance.

Pickett with HealthPOINT, a federally designated regional resource and support center based on the DSU campus, said 80 percent of primary care providers in the state have signed up with his agency and have begun the education process. It's possible the state might not get to 100 percent, he said. Some physicians close to retirement could decide it is too costly or time consuming, Pickett said. Some will decide they can absorb the reimbursement penal-

But in the long run, officials insist that electronic health records will improve the quality of care for patients and ultimately drive down health care costs across the state and country. Wierda Suttle said the benefit of a patient having one medical chart with all his or her records on it are signifi-

"Our electronic health record provider at Sanford is EPIC," Wierda Suttle said. "So if the patient goes anywhere else in the world that has EPIC, and I mean, a lot of foreign countries have EPIC, then they have access to whatever happens here in Sioux Falls."

At present, the major health systems in South Dakota and other providers are in dialogue with each other so that even if they don't have the same electronic health records software, they can still pass important parts of patients' records back and forth to each other, said Dr. Tad Jacobs, chief medical officer for

Avera Medical Group.

"Being able to exchange electronically between institutions a continuity of care document is a big step," Jacobs said. "That document basically will have the main things. ... my allergies, my demographics, my medications, the last tests I had done. It's kind of a snapshot of information on a patient. I think within the next 12 months that we'll successfully be able to make that type of exchange happen among institutions.

Within the next two weeks, pilot sites are being launched in the state to test the ability to "push" — or electronically send – patient information from one institution to an unaffiliated second institution, DeWald said. Further out this year, he foresees the possibility of real-time access of a patient's records among unaffiliated health care providers.

"I'm just talking about information you would need in an emergency situation. ... Your demographic information, your insurance, your most recent lab test, or your most recent X-ray," DeWald said. "From a consumer perspective, we don't need to share their entire record. It's really only what is needed in case of an emergency.'

All of that information is encrypted, Avera's Jacobs said, ensuring the security of electronic health records and consumer's personal, private information.

'The government requires us to meet certain security provisions to even participate, or we'll be penalized," he said. "There are many layers of security. When I see those types of things myself, I'm very reassured.'
