#### **Neb. Lawmakers Pass High School Dropout Bill**

LINCOLN, Neb. (AP) — Nebraska lawmakers have passed a bill that would make dropping out of high school more difficult.

Lawmakers voted the bill through its final reading Tuesday, 28-

20. The measure by Lexington Sen. John Wightman would only allow students to drop out before age 18 if they can show that they have to work to support their family, or cannot attend school because of an illness.

Wightman has said letting students drop out before age 18 severely limits their job prospects. Opponents countered that the bill infringes on parental rights, and could lead to classroom disruptions from older students who don't want to be in class.

Current law allows students to drop out at age 16, if they receive a parent or guardian's written consent.

#### **Neb. Gov. Opposed To Prenatal Care Bill**

LINCOLN, Neb. (AP) — Nebraska Gov. Dave Heineman says he's strongly opposed to a bill that would restore prenatal care coverage for illegal immigrants.

The Republican governor said in a statement Tuesday that he objected to the use of taxpayer money for benefits that would go toward illegal immigrants.

Lawmakers are set to begin first-round debate on a measure that would reinstate coverage to the unborn children of mothers who were deemed ineligible for Medicaid. It also would cover women in prison.

About 1,600 women lost their coverage in 2010, when the federal government ordered the state to stop offering services through the program. Roughly half were illegal immigrants.

The bill would extend coverage to an estimated 1,200 unborn children per year. It would cost \$2.6 million per year in federal and state money.

#### **S.D. State Government Wins In Lottery Frenzy**

RAPID CITY (AP) — State government was the biggest winner in South Dakota in Friday's record-breaking Mega Millions drawing. South Dakota Lottery spokeswoman Kelly Thompson told the Rapid City Journal that more than \$1.1 million was spent in South Dakota on Friday's game. The state gets an estimated 25 percent of

Winning tickets were sold in Illinois, Kansas and Maryland, meaning the \$640 million prize will be split three ways.

ticket sales, or about \$282,000 from the Friday drawing.

A Sioux Falls man claimed a \$250,000 second prize on Monday. Three tickets sold in South Dakota also won \$10,000 third prizes.

## **Neb. Lawmakers Approve** \$2.5M For Child Welfare

LINCOLN, Neb. — Nebraska lawmakers approved \$2.5 million Tuesday for child welfare providers that haven't been fully paid, citing both a legal and moral obligation as they narrowly over-

rode Gov. Dave Heineman's veto. Lawmakers voted 31-12 to overpower the Republican governor's veto and pay the group homes, counselors and other services left in limbo by a state contractor.

Heineman used a line-item veto to strike the payments from a larger state claims bill. He argued that the payments would amount to unconstitutional special legislation and said the bill would make taxpayers responsible for the debts of a private organization. Overriding the veto required approval from at least 30 of the Legislature's 49 senators.

Omaha Sen. Steve Lathrop, who filed the override motion, said the state has both a legal and moral duty to pay the providers. Most received 35 cents on the dollar under an agreement worked out by state officials.

Lathrop said the state paid \$105 million to contractors when it began to privatize services, even though officials spent \$107 million the year before. He said the state, as a result, failed to fulfill its obligation to the organizations that cared for children.

"It was never enough money to

get these people paid," Lathrop said. "And when you look at the fact that we amended these contracts over and over and over to provide additional dollars, it's clear they were underfunded.'

The payments were proposed to reimburse subcontractors that worked for the Boys and Girls Home, a private child welfare service provider that had a contract with the state.

The providers had subcontracted with Boys and Girls Home of Sioux City, Iowa, which lost its state contract in 2010 because it had not paid subcontractors. Law-

Lincoln Sen. Kathy Campbell, chairwoman of the Legislature's Health and Human Services Committee, said the lack of payments forced mom-and-pop providers throughout the state go bankrupt. Child advocates say the resulting financial troubles have damaged the state's network of counselors, group homes and other service providers.

# **Probe Finds Mislabeled Gasoline**

ABERDEEN (AP) — State officials are investigating the mislabeling of gasoline sold in South Dakota, though they do not know how widespread the problem is or whether there has been any intentional fraud.

An investigation found that 85 octane gasoline has been sold at multiple locations labeled as 87 octane or 89 octane, fuels that are considered to help an engine perform better, David Pfahler, director of weights and measures for the South Dakota Department of Public Safety, told the American News. Some 87 octane also has been mislabeled as 89 octane, he said.

Improperly labeling gasoline is a misdemeanor punishable by up

to 30 days in jail and a \$500 fine, though officials said their emphasis is not on prosecuting violators.

'My focus is to make it stop," Pfahler said.

It is unclear if gas stations were knowingly mislabeling gaso-line or if they did not realize that they were getting lower-level octane fuel from a distributor.

"We have no way of knowing who is ultimately responsible," Pfahler said.

He said 85 octane gas is more commonly sold in areas of higher altitudes. It is common in the Black Hills of western South Dakota. The investigation was sparked by reports of that fuel moving east.
