The course addresses area command and staff issues, as well as planning, logistical and fiscal considerations associated with complex incident management and interagency coordination.

Audience: The course is intended for individuals who may assume a supervisory role in expanding incidents or Type 3 incidents. Note: During a Type 3 incident, some or all of the command and general staff positions may be activated, as well as division or group supervisor and/or unit leader positions. These incidents may extend into multiple operational periods. Prerequisites: ICS-100 and ICS-200, IS-/ICS-700, IS-/ICS-800 Stu-

intentional fires that get out of control — will take its toll. "Somebody is going to end up

getting hurt," he said. Even if no one becomes killed or injured, the continual fire calls create stress for the firefighters, Hoffman said.

"These (firefighters) are all volunteers, who are leaving their jobs, sometimes two or three hours at a time," he said.

The resolution enacting a burn ban was passed unanimously at Tuesday's meeting by board chairman Brad Henke — who is also the Parkston fire chief — and fellow commissioners Jerome Hoff, Glenn Harnisch, Gillas Stern and Dallas Laffey.

The commissioners took the action after consulting Tuesday with Hoffman. He had previously consulted with local fire and lawenforcement officials in regard to the severity of the issue.

2. With the issues facing the district — a budget shortfall projected for this year, a general fund reserve balance that is almost depleted, public relations issues with the community, the health insurance fund, etc. what do you bring to the table that will help solve these issues. I will bring an always positive attitude and an unbiased look at our school operations. I am not connected to the banks where the money is invested. I am not connected to the school district staffing and I am not a health care plan manager. Not that these attributes or positions of employment are bad or that we may be doing something not completely correct in these areas currently. With no financial attachment to these business lines I am confident that I can honestly be an unbiased manger of school district and constituents moneys and be a representative of the entire community. I do not and will not profess that I know the answers to the difficult questions but that I will pursue solutions.

The burn ban resolution notes the emergency action was taken because "unduly hazardous fire conditions now exist in Hutchinson County." The ban will remain in place "until fire conditions improve as determined by the emergency personnel within Hutchinson County."

The resolution carries a fine not to exceed \$200 for each violation or by imprisonment if found in violation of this resolution. The individual(s) responsible for setting the fire can also be held responsible for costs for suppressing the fire, including response fees, mutual aid assistance and compensation to the firefighters for the time from their employment.

An emphasis has been placed on getting out the word about the burn ban as quickly as possible, according to Hutchinson County Auditor Jeannie Simonsen. She enlisted the *Press & Dakotan's* help in reaching the public.

⁴I have also contacted all of our fire chiefs and city finance officers in the county," she said. Allowances will be made for authorized burns by contacting Hoffman at (605) 928-3042 or (605) 770-7927.

However, Hoffman said no circumstances exist at the present time for safe open burning. Any burning, such as trash, must have a lid, he said.

"There is no such thing as a controlled burn, because there is no way to control it with this wind and dry conditions," he said.

Hoffman doesn't see any immediate relief resulting in the lifting of the ban.

"Even where there's grass, the green grass has dry grass mixed with it," he said. "There isn't enough green to stop things from burning."

When contacted by the *Press* & *Dakotan*, Bon Homme County emergency manager Jon Vavruska said his county's burn ban remains in effect. He doesn't see any significant change in conditions that would result in lifting the burn ban.

Meanwhile, the National Weather Service in Sioux Falls has issued a fire warning for

He was treated for exhaustion in Sioux Falls in October after he completed a lecture tour. Two months later, he fell and hit his head, just before he was to be interviewed on C-SPAN for a program called "The Contenders" that focused on failed presidential candidates who had a lasting impact on American politics.

McGovern lost in a historic landslide in his 1972 challenge to President Richard Nixon, who eventually resigned amid the Watergate scandal. Most of his work in recent years has focused on world hunger.

He and former Republican U.S. Sen. Bob Dole were honored in 2008 with the World Food Prize. Their George McGovern-Robert Dole International Food for Education and Nutrition Program, established in 2000 and funded primarily through Congress, provides millions of meals to children in the U.S. and some three dozen other countries.
