IRS Seeks Volunteers For Taxpayer Advocacy Panel

ST. PAUL, Minn. - The Internal Revenue Service seeks civicminded volunteers to serve on the Taxpayer Advocacy Panel (TAP), a federal advisory committee that listens to taxpayers, identifies key issues, and makes recommendations for improving IRS service.

"TAP members give the IRS insights from every corner of our nation, helping the agency in its continuous effort to improve tax administration," said IRS Commissioner Doug Shulman.

The TAP is seeking members or alternates in more than two dozen locations, including the Midwest states of Minnesota, North Dakota, South Dakota and Wisconsin. Applications for the TAP will be accepted through April 27, 2012. The TAP provides a forum for taxpayers from all 50 states, the District of Columbia and Puerto Rico to raise concerns about IRS service and offer suggestions for improvement. The TAP reports annually to the Secretary of the Treasury, the IRS Commissioner and the National Taxpayer Advocate. The Office of the Taxpayer Advocate, an independent organization within the IRS, provides oversight of the TAP.

Clean-Up Event Brings In A Big Haul

The Great American Cleanup in Yankton was a great success, according to Keep Yankton Beautiful (KYB) officials. The cleanup took place in Yankton last

Saturday, and more than 130 volunteers came out to help clean city streets and public green spaces.

There were teams from HyVee, First Dakota National Bank, Home Federal Bank, Sacred Heart Church, TruXedo, Sapa, Boys & Girls Club, Boy Scout Pack 258, Mt. Marty College, Knology, Gehl, Keep Yankton Beautiful, RSVP Group, Yankton Area Ice Association, Yankton Children's Theatre and Roger's Family Pharmacy. Also, many individuals and families who came out to help with the cleanup this year.

In all, 1,530 pounds of trash was collected and taken to the transfer station by volunteer City of Yankton driver, Jim Flynn. An additional six bags, bringing the total weight to more than 1,600 pounds, was brought to the transfer station later.

KYB members Pam and Jack Frick and volunteers Steve Ellis and Jake Hoffner drove pick-up trucks and trailer beds around town to gather the trash and bring it back to Me-morial Park and the City of Yankton hauler.

Because of the record volunteer turnout this year, KYB was able to get to more routes, adding old 50 East (Whiting Drive) and parts of Fourth Street/Highway 50 East. In all, the cleanup covered 30 miles around the community, with a large group from Mount Marty College taking Chalkstone Road and 52 West towards the Lewis & Clark Lake area. This year's collection total, while impres-

sive, was 500 fewer pounds than was collected last year — even with the addition of routes. KYB officials said it means things are trending in the right direction and it is a great

According to KYB Executive Director Julie Perakslis, "This cleanup is a lot of fun. I went out last year with a group of Vermillion students, KYB members and members of Boy Scout Pack 258. We found one half of a scooter, a pile of wooden pallets and lots and lots of trash. It was a great morning, a fun boat ride and an adventurous cleanup."
