Neb. Priest On Leave Amid Abuse Allegation

OMAHA, Neb. (AP) — An Omaha priest has been put on administrative leave amid an allegation of sexual abuse when he was at a Norfolk parish in the 1970s, the Archdiocese of Omaha said Sunday.

Deacon Timothy McNeil, chancellor of the archdiocese, said the allegation against Rev. Franklin Dvorak came to light at the end of March. He is accused of sexually abusing a female student from 1970 to 1972, when he was stationed at Norfolk Sacred Heart Parish. Sacred Heart runs a school, now called Norfolk Catholic, that serves students in kindergarten through 12th grade.

A message left Sunday at the parish office wasn't immediately re-

Dvorak has denied the allegation, which was first reported by WOWT-TV.

Dvorak, who was ordained in 1970, was appointed pastor of St. Elizabeth Ann Seton Parish in Omaha in 2007.

McNeil said Dvorak was removed from the parish the first week of April and was officially placed on leave on Friday, after an internal review board found the claim credible.

The case is being forwarded to Congregation for the Doctrine of the Faith in Rome. Law enforcement has also been notified.

Unwanted Neb. Sand Put To Use In Oil Fields

GENOA, Neb. (AP) — Some unwanted Nebraska sand has been put to use in some U.S. oil fields.

The Columbus Telegram says sand that's been dredged from the head of a power canal alongside the Loup River near Genoa has been accumulating for 75 years.

The Loup Public Power District couldn't find anyone to take it. Then Legacy Resources Co. began building a facility in 2006 that could ship out the sand for use in hydraulic fracturing — or fracking. That process injects water and sand into the ground to free deposits of pe-

Legacy was bought by a Pennsylvania-based investment group, which created Preferred Sands, of Genoa.

The company sells the processed sand to several companies, with the biggest U.S. demand from Colorado, North Dakota, Pennsylvania

Lakers Returns To Politics With Run For Regents

OMAHA, Neb. — Two years after abruptly abandoning his race for Nebraska governor amid a campaign finance scandal, Mark Lakers is now quietly making a bid for another elected office — this time for a University of Nebraska Board of Regents seat.

Lakers' filing for the District 8 seat last month rounded out what was already an eclectic race that included former Republican Omaha mayor and U.S. Rep. Hal Daub and Ann Ferlic Ashford, the daughter of current Regent Randy Ferlic, who isn't seeking a third term. Carl Jennings, a Democrat, also is running for

The District 8 and three others are up on the Nebraska Board of Regents. Because the races are nonpartisan, the top two vote-getters in each race advance to the November elections.

This time two years ago, Lakers appeared to be on track to give Nebraska Democrats a viable shot at taking the governor's office. Only two months earlier, Lakers had announced his candidacy at the urging of the state party, which hailed him as a successful businessman who could bring new jobs to Nebraska.

In April 2010, Lakers released his first campaign finance report, remarkable for the staggering amount of pledges he claimed he had amassed — more than \$300,000 in a three-week period — in his first run for public office.

But suspicions over the amounts surfaced within days, as executives with companies listed as having pledged as much as \$20,000



called state authorities to say no such pledges had been

Lakers, who was unopposed on the Democratic primary ticket, easily won the gubernatorial nomination in May. But a month later, he removed most of the campaign pledges he had earlier claimed, and a month after that, dropped out of the race.

He eventually admitted in court to falsifying 51 of 80 campaign pledges on his finance reports, pleaded guilty to one count of abusing public records and was fined \$500

Asked whether he fears his failed run for governor would haunt his latest race. Lakers said his work as an investment banker specializing in agriculture businesses had given him a

"To a large degree, this isn't about me," he said, acknowledging that "there was some negative" blowback from the 2010 campaign. But Lakers said he has something to offer Nebraska's university system.

"Should I be elected, I'll have an opportunity to work with the next governor and try to convince that governor to stop defunding education, not only at the university level, but defunding state support for K-12," he said. "All three of my boys recently graduated from the University of Nebraska. I understand how difficult it is to pay for education. I think the state has failed our kids by not having state guarantees on loans."

If he walked away from his 2010 failed gover-

nor's race with any lesson, it seems to be to downplay talk of money. He has been campaigning at Omaha-area events and granted interviews with some radio and television programs,

but has done little fundraising. "For the most part, I self-funded up through the primary," Lakers said. "I'm not interested in turning a Board of Regents race into who can

spend the most money.' Lakers said he doesn't know whether the Democratic Party now regards his failed 2010 gubernatorial bid as water under the bridge.

"I haven't even talked to the Democratic Party," Lakers said. "I think people need to talk about issues. I think 80 percent of Nebraskans really don't care about party.'

If those in the party have forgiven, they clearly haven't forgotten.

Anne Boyle, a former Nebraska Democratic Party chairwoman and an elected member of the state Public Service Commission, offered less than a ringing endorsement when asked about Lakers' run for the NU Board of Regents. Boyle ruffled her party in the summer of 2010 when she publicly called on Lakers to drop out of the gubernatorial race as the scandal around his campaign finances grew.

'I would give him the benefit of the doubt, as far as running," Boyle said. "I'm not sure what the voters will think when they have other candidates running as well who are qualified."

Fellow Democrat and current regents member Chuck Hassebrook joined Boyle two years ago in demanding that Lakers step down. Asked whether he supports Laker's run for the regents board, Hassebrook replied, "I'd have to think


