FREEMAN — Freeman Police Chief Eric Seitz has been suspended indefinitely following an indictment on three drug-related charges, accord-

ing to the Freeman Courier. Seitz is scheduled to appear in court May 8 on the misdemeanor charges of obtaining controlled substances concurrently from different

medical practitioners, the Courier reported. Seitz allegedly obtained the drugs between the approximate dates of Aug. 1, 2012, and Oct. 31, 2012, according to paperwork filed in Yankton

The substances in the indictment are hydrocodone and carisoprodol, the Courier reported.

Seitz turned himself into Hutchinson County authorities this week. He

posted a \$500 cash bond and was released.

Freeman mayor Sam Sorensen suspended Seitz because the bond prohibits the police chief from carrying a firearm, not because of any work-related performance issues, City Attorney Mike Fink told the *Courier*.

Astronaut Mark Kelly Set For USD

VERMILLION — Capt. Mark Kelly, astronaut and retired U.S. Navy Captain, a best-selling author, prostate cancer survivor and an experienced naval aviator who flew combat missions during the Gulf War, will be the guest speaker for IdeaFest at the University of South Dakota on April 10 at 7 p.m. in Slagle Hall's Aalfs Auditorium.

Kelly's lecture, "Endeavour to Succeed," will address his success in space as well as his personal life and how it forever changed in the assassination attempt on his wife, U.S. Rep Gabrielle Giffords (D-Ariz.). Kelly and Giffords co-authored, "Gabby: A Story of Courage and Hope," released in November 2011, which explores Kelly's public service as a pilot and astronaut, his wife's public service as a politician, and their struggles following the shooting that left her critically injured.

Kelly served as commander of Space Shuttle Discovery and flew his first of four missions in 2001 aboard Space Shuttle Endeavour, the same space shuttle that he commanded on its final flight in May 2011. He was selected as an astronaut in 1996 and received a B.S. degree in marine engineering and nautical science from the U.S. Merchant Marine Academy in 1986. In 1994,



Kelly received an M.S. degree in aeronautical engineering from the U.S. Naval Postgraduate School.

Presented in partnership with the Beacom

School of Business Opportunity Fund and the Arthur Volk Symposium, "Endeavour to Succeed" is free and open to the public and one of two lectures scheduled for IdeaFest, April 10-11. Dr. David Sweatt, the Evelyn F. McKnight endowed chairman of the Department of Neurobiology at the University of Alabama Medical School, and the director of the Evelyn F. Gavins Point Dam To Conduct Spillway Flow Test

As part of the ongoing rehabilitation and repair of the damage from the Missouri River Flood of 2011, the U.S. Army Corps of Engineers, Omaha District, will temporarily shift discharges out of Gavins Point Dam from the powerhouse to the spillway on Wednesday, April 10, to conduct a spillway flow test.

The purpose of the test is to gain additional information on the current condition of the spillway. Beginning around 7:30 a.m., releases will be diverted from the powerhouse to the spillway. Discharges will be increased from the current 24,000 cfs to 26,000 cfs for part of the day. Total releases may be increased to 40,000 cfs for a brief period of time depending on the responses observed at the lower discharge rates.

The total test period is not expected to exceed eight hours. At the completion of the test, releases will be returned to the powerhouse in accordance with scheduled daily releases.

Repair work has entailed additional investigations into the foundation conditions underlying the concrete slabs located immediately downstream of the spillway structure. Subsurface investigations are nearing completion. They included the installation of pressure transducers beneath the

spillway chute to assess and monitor uplift pressures that may develop during operation of the

"This effort is a continuation of the baseline flow testing that was conducted on March 12. It is necessary to obtain additional information regarding the current condition of the spillway," said Geotechnical Engineer Steve Butler. "Gaining this information will help us determine whether additional interim repairs are warranted and help us assess the long term reliability of the spillway's design.'

the Yankton area. If the precipitation in the Yankton area is too heavy, the test could be moved to April 11th or 12th," Butler said. "There is also a chance for heavier rainfall in the lower basin, but the run-off from these storms should be through the system before any increases in flows from this test reach the lower basin. We will monitor river and weather conditions between now and next week and, if conditions change, the test will be modified or postponed to prevent adverse impacts to river

users or adjacent landowners.'

Howard "Hod" Nielsen, age 92 of Yankton passed away early Wednesday morning, April 3, 2013 at Avera Sister James Care Center, Yankton.

Howard "Hod" Nielsen was born to Niels and Ida (Mortenson) Nielsen on March 4, 1921 in Yankton, South Dakota. He attended Yankton public schools, graduating from Yankton High School in 1938, serving as senior class president. He attended the University of South Dakota until entering the Army Air

He entered flight training in Vernon, Texas in October 1941, six weeks before Pearl Harbor. He served with the Eighth Air Force for over four years as one of the first photo reconnaissance pilots. He was stationed in England and saw combat in Europe, flying an unarmed P-38. Some of his missions included photographing coastlines of Normandy in preparation for the Allied Invasion. He was one of only seven pilots in his group of twenty-seven to survive. He was decorated with the Distinguished Flying Cross, Air Medal with oak leaf cluster, and a President Unit Citation. He achieved the rank of Captain. Because of the

about the D-Day location, he was sent back to the states where he traveled to Washington, D.C. and several other cities to debrief his superiors on his missions.

On January 11, 1944 he married Anita O'Rielly in Yankton. They lived on bases in Öklahoma City, Oklahoma and Coffeyville, Kansas until the war ended, when they returned to Yankton. While in Coffeyville, their first child Janet, was born in 1945. Karen followed in 1947, and Howard Richard, Jr. in 1955.

Following the war, Hod and his brother Roy owned and operated Nielsen Sport and Camera Shop in Yankton. Hod left the business from 1951-1954 to work with KOTA Radio in Rapid City. He returned to the business in 1954 until it closed in 1960. He then worked in the insurance business for several years.

He began doing sports play by play for KYNT in 1958, continuing for over 30 years. He became sports editor of the *Press and Dakotan* in 1968 working there for many years, writing columns daily, then weekly. He retired from his column in 2007

at age 86. He was honored to be South Dakota Sportscaster of the Year in 1976 and South Dakota Sportswriter of the Year in 1993, 1994, and 1996. He was the only person in any state to be honored in both categories.

Hod received Distinguished Service Awards from the National High School Athletic Coaches' Association, the South Dakota High School Activities Association, the South Dakota High School Coaches' Association, and Mount Marty College. Other awards include the North Central Conference Ed Kolpack Award, the USD Dan Lennon Award, the SDHSCA Max Hawk Award, the Friend of Youth from the Yankton Optimist Club, the Friend of Football Award from the SD High School Football Coaches, the Friend of the Pointers Award from Southern State Teachers College Alumni. and the Yankton College Pro Causa Citation.

Hod has been included in the following halls of fame: SD Intercollegiate Conference, North Central Conference, University of South

Dakota Coyotes, Yankton High School Sports, Yankton High School Fine Arts, South Dakota Basketball Coaches, Mount Marty College, and South Dakota Aviation. He also received an honorary doctor of letters from Mount Marty College in 2007.

In 1993 Nielsen became Yankton's Citizen of the Year. He was a member of the Yankton School Board of Education for eight years (1968-1975), serving as president from 1973-1974. He was an early organizer of the South Dakota Sports Hall of Fame and served on the Selection Board until 1999. He was the first president and one of the founders of Yankton's Quarterback Club. He was a member of Hillcrest Country Club in its early years. He served as a Heisman Trophy voter for many years.

Hod was included in Tom okaw's book "The Greatest Generation" and in Greg Laska's "Blue Stars." He belonged to the Elks Club. He was a lifelong member of Trinity Lutheran Church where he was baptized, confirmed, and married.

The fall of that year, he entered Law School and received his Law Degree in June of 1956. He was admitted to practice in the State of South Dakota as well as the State of Nebraska. He was recognized for his legal service of

He made several trips with friends to three Canadian provinces and received a Master Angler Award from the Province Ontario for season's second largest walleye caught in
