Spring Storm Creates Calving Issues Throughout South Dakota

BROOKINGS — Tuesday's storm caught many South Dakota cattle producers in the middle of spring calving. The storm's cold, wet and windy conditions will potentially cause significant losses to their calf crop, says Warren Rusche, SDSU Extension Cow/Calf Field Specialist.

This is the worst kind of weather to calve in," Rusche said. "In wet, cold, windy conditions like this, it doesn't take much to lose a newborn calf.'

Rusche blames the heavy wet snow and rain for diminishing mature cows' reserves and sucking the life out of their newborn offspring.

Cold stress with cattle is often

associated with below zero temperatures, especially in South Dakota. However, under dry conditions, cattle that are adapted to the cold conditions found in northern plains winters can function and perform well under a wide range of conditions. That adaptation goes out the window when wet conditions are introduced," Rusche said. "It is as if you soaked a down-filled coat in water and expected it to keep you warm. If a cow is soaked it quickly drops her critical temperature."

Ås far as her newborn calf is concerned, Rusche says it all depends on cattle producer's access

to dry cover. "Évery cattle producer who is

calving right now has been out in this storm trying to find, and provide shelter to every calf born. They are facing the reality that if they don't get their calves to shelter, the calves may die," Rusche said. "The risk of death loss from hypothermia is very real in these cold, wet and windy conditions. Even mild cases of hypothermia can lead to problems with colostrum intake and absorption."

While there is little that can be done to change adverse weather conditions, Rusche says there are steps that producers can take to deal with spring storms and minimize negative impacts. Some of those steps include:

Provide for as much shelter as

practical, whether natural or manmade. Shelterbelts, wooded draws and windbreaks can be invaluable forms of shelter.

Bedding will help minimize heat losses from the body, especially for calves. Newborn calves spend about 80% of the time laying down, so providing a dry surface out of the wind will help the calf keep dry and preserve body heat.

Be prepared to warm newborn calves in the case of hypothermia. Immersing calves in warm water, physically drying them off with towels, or placing them under heat lamps are all methods that have been used successfully.

Calvin Jacob Mettler, 88, died peacefully Sunday, April 7, 2013 at home on the farm 4 miles north of Menno, S.D.


Family members will be present at Zion Reformed Church, Menno for visitation beginning at 5 p.m., Friday, April 12 with a prayer service at 7 p.m.

charge from the Army in February 1953, the couple and infant son moved to his farm 4 miles north of Menno where he spent the rest of his life. They raised five sons and enjoyed sharing 61 years of marriage.

Calvin served in many community organizations: organizational boards of the Southeast Experiment Farm (vice president), State and County Extension Service, Hutchinson County Farm Bureau (president), Menno-Olivet Care Center and Menno Medical Clinic; board member of the Farmers Elevator. He enjoyed participating in the Menno Centennial Chorus, church choir, and the development of Pioneer Acres at the north edge of Menno. His heart for service was also evidenced by the two gallon pin he received for donating blood at numerous local blood drives. Calvin was a delegate to the Republican State Convention numerous times and a State delegate to the 1968 National Convention in Florida, carrying his beliefs in small government, personal responsibility and high morals to the political arena. He was a member of the American

Legion and also the SoDak Stamm Chapter of Germans from Russia Heritage Society, with whom he and Carol traveled on a tour to the Ukraine in 2005 to see the area their ancestors immigrated from.

Calvin enjoyed golf in his later years; he and Carol traveled to many different golf courses. Although they began taking winter breaks to Mesa, Arizona in the early 1990's, during the warmer months he remained active on the farm, doing things like helping with daily cattle feeding until late Fall, 2012 when his deteriorating health finally prevented it. Their grandson, Rodney, and Amanda Mettler recently purchased the farmstead from Calvin and Carol, fulfilling their wish to keep it in the family.
