### **SHIINE Seeks Local Volunteers**

PIERRE — The South Dakota Senior Health Information and Insurance Education (SHIINE) program is currently seeking volunteers for all aspects of the SHIINE program.

One of the primary functions of SHIINE volunteer is to help seniors with their Medicare questions. Volunteers receive training on all parts of Medicare and learn how to provide one-on-one Medicare counseling.

Volunteer counselors are vital to the success of the program, as they provide opportunities for seniors to discuss their Medicare questions and concerns in person. All services are unbiased and confidential.

Although volunteers are most active during Part D (prescription drug) open enrollment in the months of October, November and December, they are needed year-round. If becoming a volunteer counselor isn't for you, talk to your regional SHIINE coordinator about other ways to contribute your time and talents.

Training includes:

- All parts of Medicare,
- How to counsel people individually, • How to provide referrals, and
- How to navigate the Medicare website and plan finder tool.

Individuals interested in serving as SHIINE volunteer counselors should be comfortable using computers, the Internet, and meeting with individuals in public locations, such as libraries or senior centers. Volunteers can choose the hours they would like to provide services. A SHIINE volunteer may not hold a current license to sell Medicare-related health insurance.

# **May 1 Deadline For Property Tax Exemptions**

PIERRE — Applications for the Property Tax Homestead Exemption Program are now available to eligible property owners who wish to delay payment of their property taxes in South Dakota.

May 1 is the deadline to apply for the program. Under the state Homestead Exemption, qualified applicants can delay payment of property taxes until their property is sold. Taxes then become a lien on the property and must be paid along with interest before the property can be transferred.


To qualify for the exemption, an applicant must be at least 70 years old or a surviving spouse; have owned a single-family dwelling for at least three years or been a South Dakota resident for at least five years; have resided at least eight months of the past calendar year in a single-family dwelling; and meet the program's income limits.

The maximum amount of income to be eligible is \$16,000 for a single-member household and \$20,000 for a multiple-member

The program defines property as the house, garage and the lot upon which it sits, or one acre, whichever is less. Applicants should be aware that application and qualification for the Homestead Exemption Program make them ineligible for the Senior and Disabled Citizens Sales and Property Tax Refund Program.

Interested individuals must apply annually to their county treasurers for the Property Tax Homestead Exemption Program. Applications are available at county courthouses, the Department of Revenue's Property and Special Taxes Division, or in downloads from the department's Web site at: http://www.state.sd.us/drr2/forms/propertytaxforms.htm (see form
