"W. L. Dow, Architect" will air May 6 on South Dakota Public Broadcasting and highlights the work of Wallace Dow, who came to the prairie in the 1880s and left his mark on cities from Bismarck, N.D., to Vermillion. Old Main and East Hall, both Dow buildings and landmarks of the USD campus, are featured in the film. A question and answer session with the film's creators and producers, Brad and Jennifer Dumke of Sioux Falls will follow the screening at 3:30

"We wanted to produce a historical documentary that brings history to life, is informative, and makes history interesting and enjoyable while providing a community service in preserving the past,

the Dumkes said in a statement.

Jim Wilson, chair of the Clay County Historical Society, stated that Dow was also responsible for several prominent buildings in Vermillion, including the First National Bank Building (now Red Steakhouse), the first Vermillion Public High School and the first Vermillion City Hall. "Dow was the most prolific and famous of the early architects in South Dakota and built in a variety of styles," Wil-

"Dow seems to have done it all," said USD Associate Professor of History Molly Rozum, Ph.D. "His buildings were varied in design and purpose, from Queen Anne to Gothic and from homes and schools

I have a 2000 Subaru Outback wagon. Recently, the passenger-side daytime running light and low-beam headlight stopped working. When I got out of my car to check that the headlight was out, I happened to bump the front of the headlight casing and — lo and behold! — the headlight came back on. I opened the hood and tried to see if any wires were loose, but it did not appear so, and tugging on the wires does not cause the light to go on or off. Home For Wounded Veterans Opens In Custer

CUSTER — Veterans wounded in combat during the Iraq and Afghanistan conflicts now have a special place where they can spend a quiet week with family in the peaceful beauty of South Dakota's Black Hills — free of

Called Operation Black Hills Cabin, the all-volunteer program offers free use of a Black Hills cabin to qualifying disabled veterans from across the United States. The program began two years ago, using vacation rental cabins donated by local lodging companies. However this year, Operation Black Hills Cabin has its own dedicated cabin specifically for the vets.

"It's our thank-you gift for returning veterans from Iraq and Afghanistan," said Pat Baird, cofounder of Operation Black Hills Cabin. "This project is designed to offer a week-long respite to a qualifying veteran, at little or no expense for them to reconnect with their family and enjoy the beauty of the Black Hills. The cabin is a Governor's

House, built by inmates at the Mike Durfee State Prison in Springfield and moved to the home site in Custer. South Dakota Housing Development Au-

thority, which runs the Governor's House program, donated the house to Operation Black Hills Cabin.

We're proud to be part of this effort. Returning veterans deserve our support, and wounded veterans need even more support as they transition back to civilian life," said Mark Lauseng, executive director of South

Dakota Housing Development Authority. He noted that many of the

Governor's House vendors, suppliers of windows, hardware and other products, joined SDHDA by donating materials for the Operation Black Hills Cabin project.

The city of Custer donated land for the cabin. It is located on the edge of Custer. More than 200 businesses and individuals in Custer and the Black Hills area have supported the project with free passes to attractions, restaurant meals and other goods and services to make the veterans and their families have an enjoyable vacation, Baird said.

She said it's wonderful to have a cabin that is dedicated to Operation Black Hills Cabin. Local lodging companies were extremely generous in the program's first two years. But the companies could only offer vacations when the cabins were avail-

Now veterans can visit throughout the six-month season.In the first two years, seven families from Vermont, Indiana, North Dakota and Colorado were able to seek respite in the Black Hills, Baird said. This year already, 10 families are booked for Black Hills Cabin.

To qualify, a veteran must be 30 percent combat disabled from service in Operation Enduring Freedom, Operation Iraqi Freedom or Operation New Dawn. For more information, visit www.operationblackhillscabin.org to download an application for consideration.

Chamber Receives Calls On 'Keep It Local' Sales Pitch

Spring is upon us. Unfortunately, this is also the time of year when the Yankton area sees numerous sorts of scams and out-ofstate sales pitches begin.

The Yankton Chamber merce received a call from a concerned citizen about the group called "KEEP IT LOCAL, L.L.C. from Winterset, Iowa. Like clockwork, they have begun their program and again, Chamber officials are asking local residents not to fall for it.

They are contacting Yankton businesses and residents to participate in their shop local program. It doesn't cost the local business anything other than the discount they offer. However, the company then turns around and conducts phone solicitations to local consumers attempting to sell these cards for \$39.95 to \$49.95. While the local business may have consumers driven to their door by this sales mechanism, none of the card sales stays local.

Don't fall for this sales tactic. This outside group comes into the community under the pretense of helping to keep sales local. Yankton consumers already have many ways to receive discounts and do not need to support an out-of-state company selling cards to get a deal.

If you are looking for discounts, many local stores have websites and email campaigns where consumers can sign up for offers — all for free and no need to purchase a

If this was truly a "Shop Local" program, consumers would not be asked to purchase anything to receive a deal.

Local businesses will soon receive calls from sale representatives selling refrigerator magnets that have local emergency contact numbers of them. These are not local businesses that support local activities and groups, nor are they endorsed by the chamber regardless of what they may say. Another

group that has conducted sales is another group from Iowa selling Yankton business maps. Yankton already has an official map of the community and lake area which is distributed throughout area businesses AT NO CHARGE for the convenience of our visitors. If you would like some for your business, just call the Yankton Chamber and Visitors Center at 665-3636 to receive your copies.

Before agreeing to participate or purchase any of these types of deals, ask some questions. Find out from the representative how much comes back to Yankton. Ask if they have a business in this community. Ask if the proceeds go to a local youth or non-profit organization. Ask yourself; if what they are
