#### S.D. Seeks Preliminary Damage Assessment

PIERRE — Gov. Dennis Daugaard has asked the Federal Emergency Management Agency (FEMA) for a joint preliminary damage assessment (PDA) to begin determining the cost of damages to public and private non-profit property caused by the April ice storm in South Dakota.

Assessment teams will include representatives of FEMA, State Office of Emergency Management and local governments. The assessments will begin on Tuesday, April 30 and are scheduled to conclude Thursday, May 2. The teams will visit seven counties and one Tribe that have formally approved disaster declarations.

The assessments are an initial step in the process of estimating the extent of damage incurred by the state, cities, counties, tribes and eligible private, non-profit organizations. Damage to rural electric cooperatives and debris removal costs such as fallen tree limbs and power lines will likely be a significant part of the total cost from the ice storm this spring.

The PDA is an information-gathering process. It gives officials a preliminary estimate of the cost of repairing damage to public structures. Using that information, the Governor determines whether or not to make an official request for a presidential disaster declaration. If damages are determined to be so severe that recovery is beyond the capability of state, local and tribal resources, the Governor may seek federal assistance.

Neither the PDA process nor the Governor's request is a guarantee that federal assistance will be provided. A presidential disaster declaration authorizes FEMA to implement a recovery program that could reimburse the state, cities, counties, tribes and eligible non-profit organizations for up to 75 percent of the eligible costs related to the flooding.

VERMILLION — Michael M. Vekich, CPA, CEO of Vekich Chartered of Minneapolis, Minn., will be the keynote speaker as the University of South Dakota confers degrees to more than 1,400 students at the 126th Spring Commencement at 9:30 a.m. on Satur-

Vekich, a candidate for the nomination for governor of Minnesota in 2002, serves as chair of HF Financial Corp and Home Federal Bank, South Dakota's largest publicly-traded savings bank. Previously, he was owner and CEO of Vekich Arkema & Company, a public accounting firm servicing clients in nine countries worldwide. Additional public service positions include chair of the Board of Trustees, Minnesota State Colleges and Universities; chair of the Minnesota State Board of Accountancy; and a former member of the Rochester, Minn. Higher Education Development Committee.

In 2008, Minnesota Gov. Tim Pawlenty appointed Vekich chair of the Governor's 21st Century Tax Reform Commission. The commission provided advice and recommendations on reforming the state's tax laws with the goal of making long-term improvements in the revenue system. Four years earlier, Pawlenty appointed Vekich acting director of the Minnesota State Lottery. During his eightmonth tenure, he created the organization's first strategic plan and increased profits by 26 percent to \$100 million, the largest return to the state in the Lottery's history. Vekich received a B.A. in accounting and business administration from the University of Minnesota.


