Yankton County **Former School Lost To Fire**

A Sunday morning fire destroyed the former Beaver Creek School on a property north of Yankton.


Yankton deputy fire chief Larry Nickles said firefighters were called to a property three miles north of Yankton on SW James River Road around 6:30 a.m. on Sunday where an abandoned building was on fire, accompanied by a small grass fire.

Nickles told the Press & Dakotan there's some speculation a group of individuals may have snuck onto the property and started the fire by accident.

"The landowner said he's had a lot of trouble where people keep taking his gate down and going in and having parties around the place," Nickles said. "We suspect that possibly it could've been a campfire. ... There's no power there and there's no other reason for a fire there.

He added the building was a total loss.

The building was com-

pletely gutted out by the time firefighters arrived on scene, so it burned completely up during the night," he said.

Nickles said the eight firefighters on scene had to tackle the situation very carefully. The structure is brick that had big cracks in the walls and

we wouldn't let the guys near the building because I was

afraid that the walls might collapse," he said. "So we took care of the grass fires, extinguished what we could from the outside and it was allowed to go ahead and burn out." It was recommended that

the remainder of the structure be knocked down to avoid the possibility of a collapse at a later date. The cause of the

fire remains under investigation. Nickles said the school

may have been up to 100 years old.

Aquatic Invasive Species Website Launched

PIERRE — With spring under way, so is this year's fishing season. The South Dakota Game, Fish and Parks (GFP) has launched a new website to help inform anglers and boaters about the new statewide aquatic invasive species rules, expected to take effect the middle of May.

"In an effort to slow the spread of aquatic invasive species in South Dakota, anglers and boaters, residents and nonresidents, will soon be required to change their old ways of transporting bait and fish and comply with newly established regulations," stated Kelly Hepler, GFP Secretary. 'With that, we have launched a new website that serves as the hub of all information related to aquatic invasive species in our state.

http://sdleastwanted.com/, features information on the new laws and regulations; species information related to zebra and quagga mussels, Asian carp and invasive plants; boat washing techniques and locations; a map depicting water bodies and any invasive species it may contain; frequently asked questions related to the new laws; how to report an invasive species; a news section; and a media gallery with images and videos.

The website is also designed to be responsive; meaning that it will render on any smartphone or tablet device in an effort to meet the growing needs of digital customers. In addition to this website, a new hashtag campaign called #sdleastwanted has also been implemented allowing anglers and boaters, along with their friends and family, an opportunity to share what they are doing to help slow the spread of aquatic invasive species in South Dakota. Digital users can share their images using #sdleastwanted via Facebook,

Twitter and Instagram. New laws will require boaters and an-

glers to: 1. Clean all vegetation and aquatic invasive species from a boat, trailer or other watercraft.

2. Open or remove all drain plugs or similar devices; except when in the boat ramp parking lot or when the boat is being launched or loaded. A boat may have these devices closed or in place while in route to a fish cleaning station immediately adjacent to where the boat was loaded, but they must be opened or removed before leaving the fish cleaning station.

3. Not transport bait or fish in water taken from a lake, river or stream. Bait may be transported in water taken from a lake, river or stream only while in route to a fish cleaning station located immediately adjacent to the lake, river or stream, but must be drained prior to leaving the fish cleaning station.

"Fishing, boating and other outdoor recreational activities are deeply engrained in the culture of this state. If each of us takes responsibility to do what we can to protect our resources today, these outdoor activities will continue to be enjoyed by future generations for years to come. Many thanks to South Dakota's anglers and boaters for their patience and cooperation with the implementation of these new regulations," concluded Hepler.

The South Dakota Game, Fish and Parks will continue to keep anglers, boaters and other outdoor enthusiasts informed as to the exact date of when the new laws take effect.

Spillway Gate Repairs Set To Continue

Repairs to the spillway gates at Gavins Point Dam are set to continue through Friday, April 10, at 5:30 p.m.

The repairs, which began in 2014, include the inspection, repair and painting of the 14 gates.

The inspection of all the gates was finished in 2014," said Dave Becker, Operations Project Manager for Gavins Point. "Repair work and painting has been completed on 5 of the 14 gates. Contractors will continue work on the other nine gates through 2015 and into 2016.'

The road that crosses Gavins Point Dam will be closed from 8 a.m. through 5:30 p.m. so contractors can begin setting up equipment and barricades to close one lane of the spillway road.

The lane will remain closed throughout construction. The lane closure will create a 9-foot width restriction on the open lane of the spillway. Large vehicles and trailers should consider taking an alternate route.

Extra traffic lights will be added to help with traffic flow. There will be delays of up to four minutes in spillway area throughout the repair process. The public is asked to use caution and obey all traffic control signals and/or flagmen to ensure the safety of everyone in the area.

These closures will include overnight hours. There will be periodic closures throughout duration of the construction. People can stay informed about upcoming road closures by checking www.nwo.usace.army.mil/gavinspoint or by calling (402) 667-2546.
