



MMC Set To Interview 4 For President

Officials: Final Decision Could Be Made By Next Month

Mount Marty College officials are interviewing four finalists for president, possibly selecting the new leader at next month's trustees meeting.

MMC interim president Tom Lorang acknowledged to the *Press & Dakotan* that the Catholic college has selected its finalists for on-campus visits. However, school officials aren't releasing names at this time.

On Monday, MMC media relations director Kristi Tacke released more information to the *Press & Dakotan* about the presidential finalists' background as well as the selection timeline.

"The process of searching for the next president of Mount Marty College is moving into the next stage," she said in a statement. "Over the next two weeks, MMC will be hosting four candidates for on-campus interviews. The candidates consist of three males and one female, all of whom have extensive experience in higher education and three of them in Catholic higher education."

Hudson Pleads Not Guilty To '14 Death

A formal plea of not guilty has been entered in a Yankton homicide case.

Joshua Hudson, who stands accused of murdering his uncle Todd Hudson in March 2014, entered the plea Monday morning. His court-appointed attorney, Dan Fox, amended the plea to not guilty by reason of insanity.

Hudson has been charged with homicide in the second-degree, aggravated assault and grand theft.

Deputy State's Attorney Erich Johnke asked First Circuit Judge Glen Eng to grant the state's request to allow them access to Hudson for transport to Rapid City for a second forensic psychiatric evaluation.

Hudson has previously submitted two psychiatric exams — one administered by Dr.

The preliminary autopsy results on the death of Lincoln Hilt have been released.

In a press release issued Monday, Yankton Police Chief Brian Paulsen said the autopsy determined the 6-year-old Hurley boy, who vanished from a Yankton boat dock on Easter Sunday, died an accidental death due to drowning.

City Gives OK To Annexation And Rezoning

A plan to bring more affordable housing to the crowded Yankton real estate market cleared another hurdle during Monday night's Yankton City Commission meeting.

The commission approved the annexation of the land along West City Limits Rd. that will be utilized for the planned housing and apartment development.

Community Development Director Dave Mingo said a voluntary petition to annex the land into the city had been filed.

"Annexations through voluntary petitions by the landowner can be considered by the city commission simply by passage of a resolution — there's no hearing process involved in a voluntary petition," Mingo said. "We have been petitioned by Bob Law, Inc., who is the owner, and also Yankton Area Progressive Growth (YAPG) who has contract on the property for this an-
