

AMENDMENT TO CATEGORICAL EXCLUSION DETERMINATION

## FOR THE PROPOSED PROJECT AT YANKTON, SOUTH DAKOTA

The South Dakota Department of Environment and Natural Resources (DENR) issued a Categor-Exclusion Determination ical published on October 25, 2012, for a project that involves the installation of new gravity sewer lines, force main and the construction of a lift station within the city of Yankton. The city is proposing to expand the project to include additional sanitary sewer replacement associated with and within the construction boundaries of the Highway 50 pavement reconstruction project being performed by the South Dakota Department of Transportation (SD-DOT).

The city of Yankton was awarded \$3,330,000 Clean Water State Revolving Fund (SRF) loan on March 30, 2012 for this project. The loan has a rate of 3.0 percent and a term of up to 20 years. Repayment of the SRF loan will b with wastewater system revenues. The current wastewater rate is \$33.67 per month based on 5,000 gallons of usage. It is anticipated that the additional sewer main replacement work will be accomplished with the existing funding.

The amended project planning area is located within the city of Yankton city limits. The amendment to the East Highway 50 Lift Station project will not affect any historical or archaeological resources. The new improvements should have no adverse effects on plant life or wildlife. No other environmentally sensitive issues have been identified in the planning of this amended project. This amended categorical exclusion determination does not alter the environmental review and determination performed by the SD-DOT for the Highway 50 pavement reconstruction project.

Comments supporting or disagreeing with this decision may be submitted for consideration by DENR after publication of the Amendment to the Categorical Exclusion Determination. After evaluating the comments re-ceived, DENR will make a final decision.
