A while back, we published a poem about a mockingbird, but just because one poet has written a poem about something, he or she doesn't hold rights to the subject in perpetuity. Here's another fine mockingbird poem from Carol V. Davis, who lives in Los Angeles.

MOCKINGBIRD II

How perfectly he has mastered the car alarm, jangling us from sleep. Later his staccato scatters smaller birds that landed on the wire beside him. Perhaps the key to success is imitation, not originality. Once, when the cat slinked up the orange tree and snatched a hatchling, the mockingbird turned on us, marked us for revenge. For two whole weeks he dive bombed whenever I ventured out the screen door lured by his call: first tricked into thinking the soft coo was a mourning dove courting, next drawn by the war cry of a far larger animal. He swooped from one splintered eave, his mate from the other, aiming to peck out my eyes, to wrestle the baby from my arms, to do God knows what with that newborn.

Dear Tom and Ray: I have a 1966 Ford Mustang 2+2 (289-cubicinch) V-8 engine with four-barrel carburetor. It has more than 170,000 miles on it. It starts right away, but when I shift the automatic transmission to Drive or Reverse, it dies out every time. I changed the fuel pump and the fuel filter, but the problem persists. I would very much appreciate your advice or any suggestions I might pursue. I have had this car for almost 46 years now, and I cannot bear to part with it. Please help. I am 72 years old, and on a limited income. Mahalo. -Onofre

TOM: The problem is not the age of your car, Onofre; it's the age of your mechanics! They're all too young now.

RAY: We have a bunch of guys working in our shop, and none of them have ever worked on a carburetor, and wouldn't know a carburetor problem if it crawled up their pants leg, bit them and left a huge rash on their tuchus.

TOM: To me, this sounds like a classic "choke pull-off" problem. When a cold carbu-reted engine starts, the choke is automatically engaged in order to reduce the amount of air going into the cylinders (that's why it's called a "choke"). This temporarily richens the mixture (more gas, less air) and makes a cold engine easier to start.

RAY: But then, after a few seconds, once the engine is running, the choke is supposed to immediately "pull off" partway (it slowly pulls off the rest of the way as the engine heats up).

TOM: If the choke doesn't partially pull off immediately after the engine starts, the fuel-air mixture will be too rich, and the car will be susceptible to flooding out and stalling. And when is that likely to happen? As soon as you put the car in Drive or Reverse and ask the engine to actually do some work!

RAY: I mean, there are other things that could cause the stalling. Weak spark for any other reason would do the same thing. But if you drove (or got pushed) into my shop, the first thing I'd do is check the operation of the choke pull-off, and if it's not working, replace it. You may need to buy a whole new carburetor in order to get a new choke pull-off, in which case I'd recommend an aftermarket carburetor with an electric choke.

TOM: So, you need to find somebody who

knows what to do when he sees a carburetor. I have a few ideas for you. One is to ask other classic-car owners you know for the name of a mechanic they like. Or, you can call around to your area shops and ask if they have anyone there who knows carburetors. Most likely, you'll get a frightened silence on the other end of the line, the handset will drop and then you'll start hearing crickets. But you may get lucky and find a place that still employs an old-timer.

RAY: Or, you may need to get more proactive than that. You may need to start visiting local old-age homes. Walk around and shake everybody's hand and say "hello." BBB Alert: Beware Of Bogus Timeshare Offers

OMAHA, Neb. — BBB is warning consumers about the risks of getting involved with a timeshare escrow company called Green Leaf Escrow Services.

This business first came to the attention of the BBB in May 2012. Since then, BBB has received 324 inquiries about this company and two complaints. The company's website, www.greeleafescrowservices.com, states that it is located at 5509 Bendt Drive in Rapid City. BBB has confirmed that the business is not at this address which is a strip mall with only one occupant, an insurance agent, and its website is not legitimate.

One complainant from California reported that she initially received a phone call from a company called First Option Property Management that claimed to be a timeshare reseller and referred her to Green Leaf Escrow Services. First Option's website, which is also not legitimate, lists its address in Albuquerque, New Mexico. However, the Albuquerque BBB has confirmed that this business is not physically located at its stated address either. First Option told the timeshare owner that there would be no money upfront and agreed to sell all three of her properties in Mexico, and after each sale she would pay 5% of the purchase price as commission.

After signing the contract, the consumer was contacted by an agent" who said he was with

Shortly after this transaction, she was notified that a second fee of \$13,000 for the three properties was required for the Mexican sales tax "to close the deal." The consumer reported, "None of these expenses were mentioned in the contract or in the conversation I had with the sales or escrow agents. When I questioned these policies, I was told that I could submit a refund request on their 'Refund Policy Form' which was supposedly sent to me at the beginning of the sale. Now, no one is available by phone or email to talk to me.'

Another consumer from Massachusetts was contacted by First Option Property Management, and arrangements were made for the purchase of this person's timeshare also located in Mexico. She was referred to Green Leaf Escrow Services and told that she needed to pay the transaction fees for the sale. On two occasions the consumer wired money to a bank in Mexico totaling \$6,000. The transaction's closing was scheduled for July 13, but it did not happen.

BBB President and CEO Jim Hegarty urges consumers "to never wire money to companies or individuals they don't know per-sonally. The act of requesting a wire transfer as the method of payment is a tell-tale sign of a scam. In addition, if you are contacted by phone regarding your timeshare, get all information in writing. Don't agree to anything until you have had the chance to thoroughly check the company out with the BBB at bbb.org or call us toll-free at 800-649-6814." If you want to resell your time-

share and are approached by a company offering to help, consider these precautions:

• Don't agree to anything over the phone.

• Don't pay any money until you have actually read and understand the company's contract. You can choose a company that charges a fee after the timeshare is sold

• If there is a discrepancy in what the contract says and what the salesperson tells you, believe the contract - not the salesperson.

• Regardless of what the salesperson tells you, do not assume there is a buyer available for your particular property. These companies only advertise properties' availability.

• Check with other property owners in your development or with real estate agents serving the area where your property is located to determine if any sales have actually occurred through this method.

• Find out where the company is located and where it does business. Verify with the state licensing board that the company is licensed to sell real estate where your timeshare is located.

• Check with the BBB, state Attorney General and other local consumer protection agencies in the state where the company is located to find out the company's customer experience record.
