significant projects, regardless of funding source, that are programmed for the next four years. A public comment period ends Aug. 31. These public comments will be incorporated into the final document which will be posted on the Nebraska Department of Roads website after approval by the Federal Highway Administration on or about Oct. 1.

ON THIS DATE

75 YEARS AGO

Wednesday, August 18, 1937

- In the heaviest rain in any 24 hours since the start of the drouth several years ago, Yankton and vicinity went out of a moisture deficit during the night and this morning has an excess over normal for the year. During the past 24 hours 3.73 inches of rain were recorded on the rain gauge at the state hospital.

- It was just 75 years ago today that the great Indian outbreak occurred in Minnesota, which resulted in the Amidons being killed in the vicinity of Sioux Falls, on August 25 of the same year, threw panic into the settlers in that vicinity and elsewhere in Dakota and resulted in the Yankton stockade being built as a protection against Indian attack.

50 YEARS AGO

Saturday, August 18, 1962

- Erosion in the non-paved roadways of the Yankton cemetery has been a problem this summer, due to the unusually heavy and frequent rainfall, and at Friday night's meeting of the cemetery board, there was discussion on the subject relative to the proposed closing of one lane.

- The Yankton Hillcrest annual club tournament gets underway tomorrow with about 30 entries already signed up for competition, attempting to unseat defending Hillcrest George Thompson from the local golf throne.

25 YEARS AGO

Tuesday, August 18, 1987

- John Lillibridge has been named president, chief executive officer and chairman of the board at American State Bank. He replaces William Deam, who resigned as president and chief executive officer last week.

- Yankton's Old Milwaukee Brewers and defending champion Rapid City Gregs moved into the second round of the South Dakota Amateur baseball tournament with first-round wins Monday night.

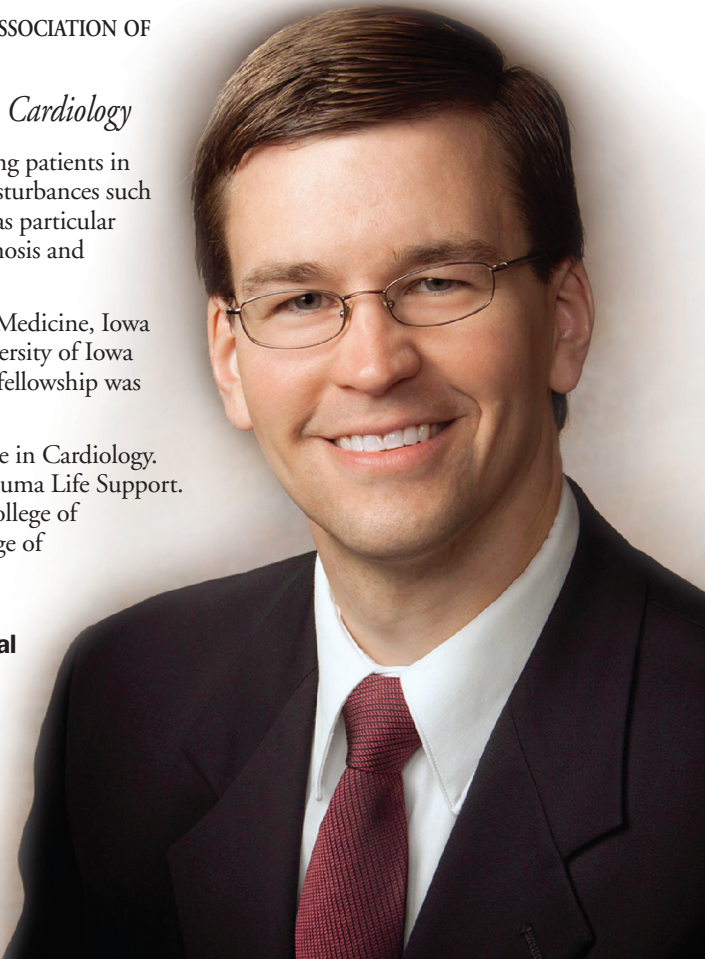
