Lincoln To Enforce Restrictions With Tickets

LINCOLN, Neb. (AP) - Police officers in Lincoln will begin issuing tickets Monday for anyone violating the city's mandatory water restrictions.

Public Safety Director Tom Casady says warnings will no longer be issued.

Since the mandatory restrictions went into effect Aug. 9, police have responded to about 475 reported violations.

Historically low water flow in the Platte River has prompted restrictions, which limit the use of outdoor water use for lawn watering and car washing. Home addresses ending in even numbers must limit outdoor watering to Wednesdays, Fridays and Saturdays and addresses ending in odd numbers must water only on Tuesdays, Thursdays and Saturdays.

Violators may be punished with a fine of up to \$500 dollars or up to six months in jail or both.

Norfolk Man Dies In Accidental Shooting

NORFOLK, Neb. (AP) - A Norfolk man is dead following an accidental shooting.

KTIV Television says authorities were called to a residence on the east side of Norfolk at around 4 a.m. Saturday.

Madison County Attorney Joe Smith says when police arrived they found 21-year-old William Webbert dead of a gunshot wound. Smith says Webbert lived in the home where he was found. He says several other people were at the home when the accident happened.

Smith wouldn't say whether drugs or alcohol were involved. He doesn't expect any arrests to be made.

Legal Fees For Killing Of S.D. Teen Top \$400K

ALEXANDRIA (AP) — Records show that Hanson County has incurred more than \$400,000 in the killing of a 16-year-old Mitchell girl more than $2 \frac{1}{2}$ years ago.

The Daily Republic reports that the costs to detain and prosecute two suspects in the death of Jasmine Guevara continue to increase. The county will ultimately only have to pay a fraction of the legal costs because it is a member of the Catastrophic Legal Expense Relief Program, which protects members from incurring catastrophically high legal expenses from any one incident

Guevara was kidnapped and killed in 2009. Twenty-three-yearold Alexander Salgado, of Fort Wayne, Ind., pleaded guilty in the case and is serving a life sentence. Seventeen-year-old Maricela Diaz of Fort Wayne, Ind., has pleaded not guilty to first-degree murder and is awaiting trial.

Teenager Arrested For Drunken Driving In S.D.

MITCHELL (AP) - A 14-year-old boy has been arrested for allegedly driving drunk while his father reportedly sat intoxicated in the front passenger seat.

The Daily Republic reports that the boy and his 49-year-old father, both of Mitchell, were arrested shortly after midnight on Interstate 90 near Mount Vernon on Aug. 5.

Police caught up to the vehicle after receiving reports that the boy was driving.

The boy's blood-alcohol content level was 0.165, more than twice the legal limit to drive. The boy was arrested for drunken driving, while the father was arrested on charges of contributing to the delinquency of a minor and having an open alcohol container in a vehicle.

They are both out on bond and scheduled to appear in court later.

N.D. Jobless Rate Lowest In U.S., Despite Rise

BISMARCK, N.D. (AP) - North Dakota had the lowest unemployment rate in the nation in July, even as it increased slightly from the month prior.

Job Service North Dakota says the state's jobless rate was 3 percent in July. That's up from 2.9 percent in June.

The national rate also rose a tenth of a point in July, to 8.3 percent.

Job Service North Dakota says the state's jobless rate was 3.6 percent in July 2011.

Group 'Disappointed' By Out-Of-State Contract

SIOUX FALLS (AP) — The South Dakota Advertising Federation says it is disappointed the state Department of Tourism has select an out-of-state company to perform a portion of its marketing for at least the next three years.

The Department of Tourism recently announced it has selected two firms for marketing contracts: Sioux Falls-based Lawrence & Schiller and Kansas City, Mo.-based MMGY Global.

The Argus Leader reports that in a letter to the state tourism board sent last week, the South Dakota Advertising Federation said it was disappointed the Department of Tourism did not award the digital contract to an agency from South Dakota.

But tourism officials say they chose firms that will provide the best marketing tools for the state.

Twelve firms from across the country submitted proposals. Three were from South Dakota.
