I believe the psychological term for it is "projection." Time magazine's painfully liberal writer Joe Klein came on MSNBC's painfully liberal commentator Chris Matthews' Hardball show to do what is routinely done there - share painfully liberal ideas with whoever is watching. And, not surprisingly, Matthews and Klein decided to pile on the Todd Akin business out of Missouri.

Amidst all the typical drivel about how Republicans are bad for women came this little jewel from Klein: "The Republican Party has a major grassroots problem which is that a good part of its grassroots now celebrate ignorance. It's more, it's more than abortion and women's rights." Pushed by Matthews to explain what he meant by "celebrate ignorance," Klein rambled on. "It's, you know, denying evolution, denying the science behind climate change, the

birtherism. How is it that when Donald Trump comes out of the closet as a major league birther, he shoots to the top of the polls, the presidential preference polls among Republicans? I mean, there is an awful lot of celebration of ignorance going on in that Party right now. It's really sad for me because there was a point 20 years ago when I thought the Republicans were coming up with some of the best policy ideas."

Right. I would have given anything to see Joe Klein make a similar comment in front of a responsible host who would logically follow up by asking, "Like what policies of the Republicans were you applauding, Joe?" For some reason, I am quite confident that he wouldn't have come up with many.

Nevertheless, let's take on the heart of what Klein suggests. First, saying that it is anti-intellectual to denv the "science" behind climate change or the "science" behind evolution is itself anti-intellectual. What many conservatives reject is not science. It's the scientific in

reject evolution (just like not all liberals who accept it) have done much digging into the issue. But exactly what is their offense? They are simply content trusting the Word of God over the word of people like Joe Klein. Based on the Bible's track record for both scientific and historical accuracy, as compared to Klein and company, that can't be characterized in any way as igno rant.

And in terms of "birtherism," let's set the record straight. A lot of conservatives have long be-

lieved that President Obama was born in the United States, but were very uncomfortable with his militant refusal to show something as simple as a birth certificate to prove it when legitimate questions arose. Shouldn't we be more concerned at the blind willingness of liberals like Klein and Matthews who apparently care so little for the U.S. Constitution that they weren't concerned at all about the issue?

And just so we're clear, Donald Trump shot to the top of the polls momentarily not because of his "birtherism," but because of his willingness to boldly confront Obama. Conservatives were tired of candidates who cowered in the face of the media and their support of this failed presidency. They

wanted a fighter, and that's what caused many to gravitate towards Trump...for a very short period of time.

But while Klein's thesis is absurd, the subject matter is not. I think it's high time we have a conversation about ignorance in our political system. And we could begin by talking about a Democrat Party that thinks you can spend your way out of debt, that boasts charismatic visionaries like Nancy Pelosi, Harry Reid, and Joe Biden as their chosen leaders, that thinks it makes sense to forbid the death penalty for rapists but to allow the death penalty for the innocent child that is the product of the rape, that thinks an increase in food stamps stimulates economic growth or that extending unemployment checks is a sign the economy is on the rebound. We could talk about a Democrat Party whose best policy ideas are the very ones that were attempted and failed throughout the 1930s and the 1960s, and that continue to bankrupt state and local

governments around the nation.

The law passed by Congress five years ago essentially says the industry will produce a certain amount of ethanol every year and American motorists will buy it.

The mandate curries favor with farmers and farm conglomerates that produce corn to be used to make the ethanol. It's a way to prop up the corn market even while it does far too little to drive down oil consumption or petroleum prices.

The dry times of 2012 have killed large portions of the corn crop, spiking prices, even while the mandate calls on ethanol producers to make more of their product. Meanwhile, farmers who have herds of cows to feed are draining their wallets to pay for higher-priced corn.

You'd think Republicans who constantly whine about government mandates would be chomping at the bit to get rid of this whacky incentive.

You would be wrong. GOP members of Congress — just like President Barack Obama and too many other Democrats - continue to kowtow to the farm vote, as fiscally illogical as that is.

Congress did allow one costly tax credit for the ethanol industry expire late last year. That's progress.

Obama should use the opportunity to waive the ethanol blending quota for this year. And Congress in 2013 should get rid of it for good.

Which side really wants to gut Medicare? That question has emerged at the forefront of the presidential campaign. In the process, what's getting gutted is facts — and, quite possibly, chances of meaningful Medicare reform.

Mitt Romney and Paul Ryan claim that President Barack Obama would "rob" Medicare with \$716 billion in cuts to pay for Affordable Care Act programs. Team Obama claims the Romney-Ryan reform plans would eviscerate Medicare and saddle seniors with huge medical bills

Nonpartisan fact-checkers such as PolitiFact.com assert that while both sides are guilty of truth-bending "Medi-scare" tactics, Republicans are the worse offenders. Conservatives counter that the fact-checkers are biased. A lie, it seems, is often in the eye of the beholder.

Take Republican charges about Obama's Medicare cuts. Obama defenders point out that the \$716 billion figure refers to cost reductions that the Congressional Budget Office projects will result from Obama's health care reform law between 2013 and 2022. The law authorizes a government panel to lower costs by restructuring Medicare programs, mainly by cutting payments to doctors and hospitals.

This is not a "death panel." Its goal is to root out fraud and waste, and it is expressly prohibited from cutting benefits or denying treatment. Still, critics have a point when they argue that the squeeze on reimbursements could lead to Medicare recipients being offered fewer services. So, while claims of granny-robbing are full of melodramatic exaggeration, they have more truth than the president's champions will concede.

Likewise, there is some truth to assertions that the money saved through these cuts will be channeled to untested new government programs. Obamacare may

And if Klein is particularly interested in evaluating the intellectual prowess of the "base" of the Republican Party, perhaps we could put a magnifying glass on the "base" of his own party: from whacked out eco-terrorists to Code Pink war protestors to the Occupy Wall Street public defecators.

not be the bogeyman painted by its foes, but even many supporters agree it is unlikely to reduce overall government spending on health care, especially when it subsidizes new benefits (such as full coverage of preventive checkups and birth control, even for those who can afford out-of-pocket payments).

Meanwhile, Romney promises to repeal all of Obama's health care law, including the Medicare cuts even though the same reductions are incorporated into Ryan's much-vaunted budget plan. Ryan's plan is not Romney's, but neither Romney nor Ryan has explained what budget changes they propose to offset the loss of those savings. Even if the Affordable Care Act is repealed, there is near-universal agreement that it will have to be replaced with other programs requiring funds.

Much Democratic criticism has focused on Ryan's Medicare reform plan (Romney largely embraces it), which would keep the existing system for anyone currently 55 or older, then phase in vouchers to help seniors buy private insurance. Democrats have claimed this could force seniors to pay as much as \$6,400 a year in additional premiums. But that figure is based on an earlier version of Ryan's plan — which, unlike the new one, did not allow future retirees the option of traditional Medicare, and had a more draconian Medicare spending cap. There are no reliable estimates of what the new Ryan plan may mean to seniors. (Whether it will make a dent in the deficit is also questionable; Medicare Advantage, which allows competition from private insurers, lowers premium costs for beneficiaries but boosts government spending.)

Health care for seniors is a highly charged issue. It's not surprising each side makes inflammatory claims. Unfortunately, both sides end up perpetuating the illusion that we can prevent fiscal catastrophe without hard choices or sacrifices.
