# Nebraska **ACLU Reports Pledge Rule Complaints**

LINCOLN, Neb. — A new rule that requires Nebraska public schools to set aside time for the Pledge of Allegiance is drawing complaints from some teachers who are worried that schools may pressure them to recite it against their will, a civil liberties group said Monday.

An attorney for the ACLU Nebraska Foundation said the group has received four pledge-related complaints from teachers — a larger number than usual — since the State Board of Education unanimously approved the policy on Aug. 10. Schools must comply to keep their state accreditation and funding, but students and teachers can still choose not to participate.

ACLU Nebraska legal director Amy Miller sent a letter Monday to superintendents throughout the state, asking them to remind schools that no student or teacher can be forced to say the pledge.

In meetings before their vote, board members repeatedly stressed that the policy gives students and teachers the opportunity to opt out. But Miller said she's concerned the new rule will still lead some administrators to mistakenly believe that reciting the pledge is

mandatory, or embolden them to require it. She said her group normally receives about one complaint per year related to the pledge, most often from students.

To have four in one month indicates to us that there's a real fear on the parts of teachers who are trying to do their job, and don't want to have to sacrifice their deeply held religious beliefs to keep their employment," she said.

Miller said one of the teachers works in Lincoln, another is from Omaha, and two others teach in smaller districts in rural Nebraska. None wanted to be identified out of

fear that they would face harassment, she said.

One teacher objected to a pledge because of a Bible passage, Matthew 5:33-37, which the teacher interpreted as forbidding oaths such as the Pledge of Allegiance, Miller said. Another cited the belief that pledging to the flag was akin to worshipping a false idol, which is not allowed in Christian and Jewish faiths. Another teacher raised free-speech concerns, Miller said.

The proposal requires the pledge in all classrooms, kindergarten through 12th grade, in the presence of an American flag. Students who object can stand or sit silently while the pledge is recited, but have to respect the rights of others who participate.

School officials modeled the proposal after a 2002 New Hampshire law and a bill introduced in the Nebraska Legislature. A three-judge panel of a federal appeals court upheld the New Hampshire law in 2010. The judges ruled that the voluntary, teacher-led recitation did not constitute state-sponsored religion. Miller said Monday she had already heard

responses from superintendents thanking her for the letter, and she expressed confidence that most school districts would follow the policy without major problems.

# South Dakota More Students Earning Degrees

SIOUX FALLS (AP) - The number of students earning degrees is outpacing enrollment at South Dakota's six public colleges and universities, according to the Board of Regents.

Associate and bachelor's degree graduates have increased by 21 percent since 2005, while enrollment has risen about 17 percent during that time, the Argus Leader newspaper reported.

"I think university attitudes nationally and in South Dakota have changed somewhat from, 'We are here. You may come here, and if you are able to succeed, good for you,' to 'We have an important role in society to educate the public, and we need to be ensuring they are edu-

cated,"' said University of South Dakota Provost Chuck Staben.

"We produce a lot of the state's professionals," he said. "Lawyers, doctors, health professionals, teachers, businesspeople, accountants, scientists."

Higher education institutions are working with South Dakota high schools to ensure students come to college better-prepared, and that accounts for part of the increase in graduates, said Jack Warner, executive director of the regents.

Colleges and universities also are increasing academic support such as tutoring and relying more on self-paced learning, said Staben and Dakota State University spokesman Erica Clements. Schools also are making an effort to personally connect with students who are considering leaving before graduation.

"When we have students who do not measure in our data in the semester after they have registered, we call them, each one, and ask them why they have not re-registered and how we can facilitate their continued success in college,' Staben said.

"We actually have seven programs we have initiated this year for new freshmen and transfers to keep them focused on academics and integrate them into all areas of student success, in the classroom and out of the classroom," Clements said.

#### **Cooler Temps, Rain Little Help To Neb. Crops**

LINCOLN, Neb. (AP) — The corn harvest is picking up in Nebraska, but last week's cooler temperatures and rain won't help with drought-damaged fields.

The U.S. Department of Agriculture says the harvest gain momentum in southeast and east central Nebraska while farmers continue to cut damaged corn for silage where moisture is still high enough.

The USDA says in Monday's report that 41 percent of Nebraska's corn crop is in poor or very poor condition, with 28 percent in fair condition and 31 percent in good or excellent shape.

The USDA says soybeans are almost done setting pods, and 22 percent are turning colors, well ahead of the average of 4 percent.

Soybeans are rated 42 percent poor or very poor, 37 percent fair and 21 percent good or excellent.

#### **Obama Plans Weekend Stop In Sioux City**

DES MOINES, Iowa (AP) — President Barack Obama has added a stop in Sioux City to his Iowa travel plans this week.

Obama will hold an event Tuesday at Iowa State University in Ames, then will return to the state Saturday.

The Democrat had previously announced a visit Saturday to Des Moines, and on Monday a campaign official confirmed Obama has added the stop in Sioux City.

The events follow Obama's three-day bus tour of the state earlier in August.

Likely Republican presidential nominee Mitt Romney also has visited Iowa, including an event last week in Bettendorf.

Iowa is among seven states where neither candidate is believed to have a significant advantage, making the states key to deciding who will win the November election.

## 5 Arrested In Whiteclay Protest Released

PINE RIDGE (AP) — Five people arrested after locking arms and blocking a road in the northern Nebraska town of Whiteclay to protest alcohol sales have been released from custody.

KOTA-TV reports that the five people were released on personal recognizance after agreeing to unlock themselves. The arrests came Sunday night, about seven hours after the protesters sat down on Highway 87. Officers also cited a boy who had a knife with a weapons violation and released him to his mother.

An estimated 150-200 people walked the two miles from Pine Ridge, S.D., to Whiteclay on Sunday to protest beer sales in the Nebraska town that borders South Dakota's Pine Ridge Reservation, where alcohol is banned but alcohol abuse is rampant.

The Sheridan County Attorney's Office says charges against the protesters are pending.

## Neb. Mayor Files Statement In Recall Drive

GRAND ISLAND, Neb. (AP) — Grand Island Mayor Jay Vavricek has filed a defense statement in a petition drive seeking his recall. The Grand Island Independent says Vavricek filed his statement

last Friday, which means the process can continue.

A former City Council candidate, Jeb Wolsleben, is leading the effort to oust Vavricek, citing in part the mayor's decision to bring back the former city administrator and ignoring the council's wishes

Hall County's election commissioner will now prepare the recall petitions, which will be given to Wolsleben on Sept. 17. He will then have 30 days to collect nearly 3,300 signatures - or 35 percent of Grand Island voters.

If enough signatures are gathered, the mayor could resign or face a special recall election.

## McGovern Giving Up Homes In Mitchell & Fla.

MITCHELL (AP) — Former Democratic presidential candidate George McGovern is giving up his homes in Mitchell and in Florida to spend more time near family in Sioux Falls, where he also has a home.

The former South Dakota U.S. senator who turned 90 last month grew up in Mitchell and spent a lot of time in the city over the years. Dakota Wesleyan University offered McGovern use of the house when the school was raising money to build the George and Eleanor McGovern Library, and the street out front was named Mc-Govern Avenue. Eleanor McGovern died at the home in January 2007.

Grandson Matt McGovern tells The Daily Republic newspaper the family is moving items from the home. University President Bob Duffett says no decision has been made on the house's future.
