longer," Roby said. "That is a concern. The damage moves from one area to the next," said Scott Rabern, the state Department of Transportation administrator who oversees ditch-closing requests. The commission closed two ditches at Yankton and a third set in the Chancellor area. Affected are:

The north-side ditch along S.D. 50 east of Yankton for approximately two miles, between Ferdig Avenue and Belair Drive;

District III has been designated an authorized sales agent for the governor's houses, and Binder handles the paperwork which determines a potential buyer's eligibility for the program.

The SDHDA could take up the issue of three-bedroom homes at its next board meeting, Binder said.

"Mark Lauseng is the (SDHDA) executive director, and he oversees what is built at Springfield," he said. "He has the overall responsibility for the governor's houses, and District III has contracted to sell the houses under their guidelines."

Lauseng couldn't be reached for comment Thursday.

Should three-bedroom homes be constructed, it wouldn't mark the first change in the houses, Binder said. The first models covered 720 square feet, and the current homes cover 1,080 square feet. The daycare centers cover 1,200 square feet and could serve as a model for a three-bedroom home, he said.

While no firm figures are available, Binder estimates a three-bedroom home would cost \$38,000. He bases the figure on the current price of \$35,500 for a two-bedroom home and an increase of about 200 square feet.

"It's a cost-neutral program," he said. "SDHDA doesn't make any money off it. Any (additional) money goes back into the program."

Binder isn't sure if the SDHDA would construct both two- and three-bedroom homes, or abandon the smaller homes and focus on the larger ones.

Binder sees more demand for three-bedroom homes by young families with children. However, elderly couples are also strong users of the homes and are showing interest in larger houses.

"There is a need for this, especially in a smaller town. I would say up to 70 percent of our governor's homes go to smaller communities," he said. "In a number of towns, the housing stock is getting old. Towns are finding that they have put forward a lot of dollars to rehab structures, and they are still old houses."

"A lot of people opt for the governor's homes because they are new, well insulated

the use of their vehicles.

"I think when someone volunteers, whether it's a field trip or whatever, you're sort of inherently taking some of those risks regardless," said board member Sarah Carda. "It seems like you can make the argument that we might be protecting our students better, if something did happen to them, that they would be better taken care of going to a limited waiver."

The school board approved the limited waiver of liability 5-0. Johnke also presented other revisions being made to the parade.

In addition to all participants signing the waivers, those who are driving in the parade or providing vehicles must submit insurance verification.

Also, in an effort to promote student involvement, students who do not wish to participate in float-building will be allowed to decorate their homeroom doors instead. Students not wanting to ride on floats in the parade will have the option of other activities, such as skits or flash mobs along the parade route.

"Hopefully we'll be getting more students engaged than we have in the past," Johnke said.

and are handicapped accessible," he added.

District III sells about 15 to 20 governor's homes a year, while about 100 are sold statewide, Binder said.

"I don't think it's an overstatement that we have sold over 2,000 homes since the program began," he said.

Gov. Dennis Daugaard told the *Press & Dakotan* that the Yankton Sioux Tribe has shown interest in the homes.

"We spent time talking about housing (during a joint meeting)," he said. "There have been substantial changes to the governor's house to make it more energy efficient. (Tribal members) are interested in the construction process and buying some of them."

Yankton Sioux tribal secretary Sam Sully said housing arose as a major topic during this summer's meeting between the governor and the tribe's Business and Claims Committee.

"It was a productive meeting, and we discussed economic development possibilities, energy efficient governor houses and the upcoming gaming compact (for Fort Randall Casino)," he said.

Some communities use the governor's houses as an economic development tools, Binder said. The homes, while built by inmates, can lead to private-sector business for the lots, foundation, landscaping and other needs, he said.

School districts find the houses may provide an attraction for new teachers, Binder said.

"The lack of housing is a common complaint among teachers who go to rural communities. They say there's no place to live," Binder said.

District III doesn't finance the houses, but financing is available from banks and the U.S. Department of Agriculture (USDA) through its Rural Development program, he said. Some homeowners also turn to family members or other sources for financing, he added.

Henderson told the *Press & Dakotan* he wasn't surprised at the response to the governor's homes.

"Housing is one of the top two or three issues in the region," he said. "The governor's housing is a pretty unique program."

Mors presented an updated report to the board about the district's new training rules and regulations that the board approved earlier this month.

Mors said the new rules, which are now applicable year-round, have received full support from parents and coaches and that those who are involved in club sports are also interested in using the regulations.

"We are going to work with the club sports so that students do not have to serve a suspension twice for the same so-called crime," he said. "So if a student gets a drinking violation and they are out for soccer, and the soccer program gives the student the same suspension that our training rules say ... then we as a school district will agree that (the suspension) has been served. That student would not have to serve the suspension again for say, wrestling or basketball or track later in the year."

Since the school is not in charge of club sports, Mors said he will request rosters from the club sport coaches, which he will use to cross-reference names on the notices the school receives for juvenile arrests.

To protect the privacy of the students, Mors will communicate with the students' parents, who will be responsible for speaking with the coaches to discuss the suspensions. If the suspensions are not served during the club sports, they will be served later during the school sports.

"It's going to take some co-operation and communication on our part, but I think it's a good thing," Mors said.

No one wrote letters of opposition and no one testified against the closures during the commission's public comment period.

Convincing the Legislature to ban ATVs from state highway ditches throughout South Dakota would be "extremely difficult," according to Bill Nevin, a lawyer for the state Department of Transportation.

"But you're right," Nevin said. "We're chasing after the dog."

"I don't know that anybody knows what the long-term direction is going to be," state Transportation Secretary Darin Bergquist said.
