# **Ellsworth Flights Resuming After B-1B Crash**

SIOUX FALLS - Flights were resuming out of Ellsworth Air Force Base in South Dakota on Thursday, three days after a B-1B bomber crashed in a remote area of southeastern Montana, an Air Force official said.

Two pilots and two weapons system officers safely ejected Monday morning before the South Dakota-based bomber crashed near Broadus, Mont.

Col. Kevin Kennedy, commander of the 28th Bomb Wing, said the base temporarily shut down flights until maintenance and operations group commanders could ensure Kennedy that it was safe to resume normal flying operations. Kennedy said he made the decision Thursday that flights would

recommence that day.

Col. Brooks McFarland, commander of the 28th Maintenance Group, said the cause of the crash remains under investigation. He said crews at Ellsworth have carefully inspected all of the B-1Bs for airworthiness before releasing them to fly.

"B-1s have continued their missions elsewhere, and I have been in contact with the maintenance leadership of those units," McFarland said in a statement. "With no evidence of fleet-wide problems, it is important that we resume flying and keep proficient at our primary mission.'

The last time a B-1B was destroyed in a crash was on Dec. 12, 2001, when a bomber involved in the war in Afghanistan slammed into the Indian

### Ocean near the island of Diego Garcia. In April 2008, an Ellsworth B-1B bomber caught fire after landing at al-Udeid Air Base in Qatar.

Aerial photos of Monday's crash site show a massive charred area of prairie land void of recognizable aircraft parts. Some people who live near the remote locale say the plane broke apart in midair, scattering debris over several miles.

## S.D Has Surveyed 240,000 Acres For Pine Beetles

PIERRE (AP) — More than 240,000 acres in South Dakota's Black Hills have been surveyed for mountain pine beetles infestations since the state launched an effort to fight the beetles two years ago, Gov. Dennis Daugaard said Thursday.

As a result of the surveys, crews have treated 335,000 trees. Nearly 200,000 trees have been cut down on private land, and 135,000 trees have been cut in Custer State Park and other state lands.

Daugaard said the effort is aimed at slowing the epidemic that kills trees.

"We have not yet 'beat the beetles,' but we will continue working to protect the Black Hills," the governor said in a written statement.

Landowners can sign up through Sept. 13 for the 2013-2014 season of surveying and marking infested trees. After crews identify and mark infested trees, landowners are responsible for treating infested trees.

fort to increase financial aid and outreach programs for Nebraska high school students has helped increase the numbers of those pursuing a two- or four-year degree, college administrators said Thursday.

Administrators from the University of Nebraska and the state's colleges said a grant program aimed at high schools has allowed more of the state's students to make campus visits.

The University of Nebraska and state and community colleges also pointed to offer tuition assistance and a two-year tuition freeze approved by the state this vear.

Nearly 65 percent of Nebraska high school students went to college in fall 2006, with the state ranking 19th nationally. Nebraska climbed to 7th place in 2010, with nearly 70 percent of high

newest available data in a 2013 report from Nebraska's Coordinating Commission for Postsecondary Education.

"A key factor in sustaining and improving this ranking is for students to visit a college or colleges of their choice," Nebraska Gov. Dave Heineman said during a news conference at the University of Nebraska-Lincoln. "The likelihood of a student attending college increases dramatically if that student has made at least one college visit.'

The effort is part of the Nebraska P-16 Initiative, a joint effort of 27 business, government and education groups to improve student achievement. The University of Nebraska has maintained below-average tuition compared to peer institutions, and took \$10.4 million from its operating budget in 2011 to pay for need-based financial aid

Earlier this year, lawmakers approved \$62.1 million in Heineman's proposed budget for a two-year tuition freeze at the University of Nebraska. The budget also

included \$6.2 million for the Nebraska State College System. University of Nebraska

President J.B. Milliken said students weigh a combination of factors, including affordability and financial, when selecting a college.

"These are critical questions that families have to grapple with when visiting colleges," he said.

The campus visits are particularly important for students who may have little to no familiarity with higher education, said Jacque Carter, the president at Doane College in Crete.

"It is especially important for first-generation college students who might have uncertainty about whether they can attain a college degree," Carter said.


