SD Judges Receive Prestigious USD Women In Law Honors

VERMILLION — The University of South Dakota Women in Law presented its 2014 Attorney of the Year award to Sixth Circuit Court Judge Kathleen Trandahl and Seventh Circuit Magistrate Judge Shawn Pahlke. The corecipients of the award were both graduates of the University of South Dakota School of Law's Class of 1985. They were also founding members of Women in Law.

Trandahl received her undergraduate degree from Augustana College in 1982 and her J.D. from USD in 1985. She practiced law in Winner until she was appointed to the Circuit Court bench by Gov. Walter Dale Miller in 1994. She is the Senior Circuit Court Judge in the Sixth Circuit. She is active in many civic organizations in her community and led the effort to establish drug courts in South Dakota.

Pahlke received her undergraduate degree from Black Hills State University in 1981 and her J.D. from USD in 1985. She served as a prosecutor for the Pennington County State's Attorney before moving into the Pennington County Public Defender's Office where she was the first female director of the Public Defender's Office. She began her work as a Magistrate Judge for the Seventh Circuit in 1995, only the second woman to serve in this capacity. Pahlke serves on the Unified Judicial System Training Committee and

also writes ethics opinions

for the Unified Judicial System. She has played an important role in the implementation of drug courts in western South Dakota and serves as one of two drug court judges for the Northern Hills Drug Court. Pahlke is the first drug court judge to serve the Seventh Circuit and is among the first in South Dakota.

The award was presented on June 19 by current USD Women in Law President Kelsey Weber at the South Dakota Women in Law social held at Face it Together in Sioux Falls. The award is given based on nominations from members of the legal community, and voted on by members of USD Women in

Chapter 7 vs. Chapter 13

Dear Dave, What's the difference between a Chapter 7 bankruptcy and Chapter 13

bankruptcy? —Claudia

Dear Claudia, Chapter 7 bankruptcy is what most people think about when they hear the word "bankruptcy." It's total bankruptcy, almost like dropping an atomic

bomb on your entire financial picture. Virtually all of your unsecured debt (except student loans, child support and money owed to the IRS) is wiped out. These things are not bankruptable. About 98 percent of the time, creditors of your other unsecured debt - things like credit cards and alike - get nothing. Items that are secured debt, such as your car or house, are treated a little bit differently. If you're behind on payments, you may be allowed to get current. In most cases, banks will allow you to re-sign in a process called reaffirming the debt.

Chapter 13 bankruptcy is a payment plan structured over five years. In it, you have to pay all of your secured debt. If it has a lien on it, you pay 100 percent to keep the item. You also have to pay a portion of your unsecured debt. Again - like in Chapter 7 - debt to

the IRS, child support and student loans don't go away. For any other un-

secured debt, you can pay a percentage of what's owed. An overall payment plan is developed, and you make those payments for five

The Scottie Stampede is a nationally sanctioned event, this year drawing 336 entries from South Dakota, Iowa, Minnesota, North Dakota, Nebraska, Iowa and Wyoming.

"We're looking at some new faces (among contestants), and we have quite a few who have come back for years," Halverson said.

With the Scottie Stampede as a sanctioned event, contestants can pick up cash and valuable points on the rodeo circuit, Halverson said. Competitors often juggle their weekend schedule to make sure they enter the rodeo.

In the process, the Scottie Stampede benefits from its Saturday-Sunday schedule,

Halverson said. "With the SDRA (South Dakota Rodeo Association), we have two rodeos out west this weekend," he said. "(Contestants) usually try to hit both of them and then come across the state and hit us on Sun-

Last year's parade drew 60 entries. The parade features six categories: antique, automobile, youth, organizations, commercial and equestrian.
