VERMILLION — The Vermillion school board president has received state honors as the Outstanding School Board Member of the Year.

Chris Esping recently received the award at the joint convention for the Asso-

ciated School Boards of South Dakota (ASBSD) and the School Administrators of South Dakota (SASD), held in Sioux Falls.

Melody Schopp, the state Secretary of Education, presented Esping with the plaque during the ASBSD awards luncheon. The honor is given to a school board member who exemplifies extraordinary leadership in public education.

Esping was also recognized for the award at this week's Vermillion school board meeting.

"It's an honor because there are so many dedicated school board members across the state," she told the *Press & Dakotan*.

Accident Leaves One Dead

One person was killed in a two-vehicle accident at 4:36 p.m. Thursday on Highway 50 near the intersection with Timberland Drive west of Yankton. According to the Yankton County Sheriff's Office, a 2003 Dodge pickup truck hauling a trailer was westbound on Highway 50 when a 1990 Buick LeSabre driven by Travis Hayes, 21, Yankton, pulled out of a driveway on the north side of the road and into the path of the pickup, which was driven by Samuel Arens, 24. The vehicles collided and wound up in the south ditch. Hayes, who was not wearing a seat belt, was pronounced dead at the scene. Arens and a 16-year-old male passenger were taken to a medical facility with non-life-threatening injuries. They were both wearing seat belts. The sheriff's department and Yankton County emergency responders were on the scene.

SD Court Nixes Death Sentence Appeal

PIERRE — The South Dakota Supreme Court has upheld the death sentence of a man convicted for his role in killing a state prison guard three years ago.

Attorney General Marty Jackley said Thursday that he'll ask state court officials to set an execution date for Rodney Berget. He was sentenced to death after pleading guilty to killing prison guard Ronald Johnson on Johnson's 63rd birthday during an escape attempt in April 2011.

"The heinousness of the crime, as well as Berget's extensive criminal history, hopeless chance of rehabilitation and multiple attempts of escape leave no alternative but to protect the public through imposition of the death penalty," Jackley said in a statement.

The state Supreme Court overturned Berget's initial death sentence because of an error by the judge in the case. But Berget was sentenced again to death last year.

His attorney appealed, saying

Regents Want Tuition Freeze

Tuition Would Be Frozen For Second Straight Year At State Universities

PIERRE — The South Dakota Board of Regents wants to continue a tuition freeze for in-state students at the state's six public universities for another year, saying the funding is necessary to keep tuition affordable and the state's colleges competitive.

The state's higher education governing body approved its annual legislative budget request, which asks for about \$12.8 million in all, including \$6.8 million in exchange for keeping tuition level.

In their budget, the regents made the tuition freeze their highest priority.

Legislators granted the re-

tuition for a second year will cost taxpayers slightly more, but it's a worthy investment, said South Dakota State University President David Chicoine.

Yankton Native Wins Honor

Kevin Koliner To Be Recognized By Group As Top Prosecutor

Assistant U.S. Attorney Kevin Koliner, formerly of Yankton, has spent the better part of the last decade helping prosecute human trafficking across the state of South Dakota.

"It was a way to be a lawyer and serve my community," Koliner said. "The work is really fascinating." Koliner's dedication to the field is paying off. A couple months ago, he was informed that he's won the Women In Federal Law Enforcement (WIFLE) Top Prosecutor Award, which will be presented to him Aug. 27.

"The nominations are for people whose work has protected women and children," he said. "The reason I won it was for my sex trafficking prosecution."

This was Koliner's first nomination for the award, and he was nominated by the Department of Homeland Security.

Koliner said this distinction came as a bit of a surprise to him.

"It was a shock — I didn't know I was nominated," he said. "I was proud and very humbled since I know full well my job is one of many in the prosecution of these crimes."
