U.S. Checking Reports Of 2nd American Killed In Syria

WASHINGTON (AP) — The U.S. is trying to determine if a second American fighting with the Islamic State group has been killed in Syria.

State Department spokeswoman Jen Psaki said Wednesday that the U.S. has no independent confirmation of reports of a second American killed while fighting with the militant group. We're looking into it," she said.

NBC cited an anonymous member of the opposition Free Syrian Army as saying two Americans were killed in a battle last week with Islamic State fighters.

The U.S. confirmed the death of one

American, Douglas McArthur McCain, who grew up outside Minneapolis in the town of New Hope and most recently lived in San Diego

A relative, Kenneth McCain, told The Associated Press that the State Department called to tell his family that Douglas McCain had been killed in Syria. "We do not know if he was fighting anyone," he said.

Investigators were aware that McCain was in Syria to fight with the militant group, said a U.S. official who was not authorized to discuss by name an ongoing investigation and spoke only on condition of anonymity.

"At the same time, having that combined valuation would protect our taxpayers."

Wednesday's gathering represented the first open meeting for the study committee. The group members, comprised of board members and administrators, had closed their meetings to the media and public. The committee cited the closed meetings as needed for more open and comfortable discussions and a free flow of information.

The districts had set up a five-school website for posting minutes, information and answers to the public's questions. However, the closed meetings raised some concerns from the media and public, and the five boards decided to open the committee meetings.

At Wednesday's meeting, the committee heard an extensive report from Corey Epler with the Nebraska Department of Education on the state's workforce needs.

Epler spoke of the disconnection that often occurs between available jobs and what schools are offering in terms of training to meet those needs.

In that respect, Epler praised the five schools for their continued focus on curriculum, job training and preparing students for life after graduation.

"We (at the state level)

your (five-school) discussion continues to be grounded in what is best for students," he said.

The committee had broken into sub-committees, who presented their findings for further discussion.

When it comes to the secondary school, the committee discussed the advantages of grades 9-12 versus 7-12. Thev noted, while a 9-12 school may have lower construction costs at first, the 7-12 would open up more opportunities for shared staff and allowing the younger students to explore different career areas, course offerings and extracurricular activities.

Other discussion involved the idea of surveying other schools which have consolidated or had failed in the effort in order to learn from their experiences.

The sub-committee reports also focused on hiring an attorney to handle legal matters related to the five-school effort, possible architects and building options, and expanding the curriculum.

The committee also discussed taking the five-school information to local businesses and organizations as well as exploring possibilities for apprenticeships and other work-related experiences.

John Blaylock, a vice president at Northeast Community College in Norfolk, was present at the meeting and offered his school's assistance in workforce training. Blaylock also noted opportunities for helping students transition to post-secondary institutions

During Wednesday's meeting, the five schools learned that each of them had qualified for a \$5,000 grant for planning purposes tied to the joint-school discussion.

The next study committee will be held at 7 p.m. Oct. 8 in Osmond. The five school boards will hold a joint public meeting at 7 p.m. Nov. 12 in Wausa.

Jensen, the Creighton superintendent, noted the five schools' effort was being watched closely across Nebraska. In many ways, the success of the five-school venture could mean survival for the northeast Nebraska districts, he said.

'We need to look at the economic impact of this. We have real opportunities for stimulating growth and strengthening relationships,' he said. "We can create an employment link with a pipeline of workers. We can make a connection, instead of a disconnections, where students leave and then we have the population loss that all of us are experiencing.'

The five school districts hold the power to control their destiny, Jensen said.

"We can bring all of these aspects together and grow our communities, rather than lose population," he said. "We will be able to keep our young people and build our future."

The wagon train will spend Sept. 6-7, a Saturday-Sunday stay, in Tripp, Olson said. Plans call for a dinner and short program Saturday evening at the fairgrounds, a fireman's dance on Main Street that night and a Sunday morning breakfast and cowboy church service on the fairgrounds before the riders depart.

Olson plans for his Hutchinson County community to double in population with the wagon train's arrival.

"I talked to the organizers two weeks ago, and they said that 100 (wagon train riders) signed up," he said. "We are expecting a lot more people when they arrive in Tripp. We are planning to host 700 people, when it comes to putting together food and getting the needed areas. We want to be prepared for that number."

The action begins when the wagon train arrives in Tripp late Saturday afternoon, Olson said. He expects a buzz of activity as wagons, horses, riders and spectators fill the fairgrounds.

"The wagon train is coming into town from the east, on a gravel road, between 4-5 p.m.," the mayor said. "Our Legion will meet them with the honor guard, and the wagon train will go straight to the fairgrounds.

The public is encouraged to welcome and spend time with the wagon train during its stay, Olson said. The events are open to the general public, although the Saturday meal and dance carry a charge.

'We have heard the riders like to eat right away so they can set up their wagons and feed their horses when they get into town," the mayor said. "We will start serving the Delmont sausage supper at 6 o'clock and continue serving through the program that starts at 6:30.

The program, expected to last an hour, will feature both the fun and educational, Olson said. Local historians Gary Jerke of rural Tripp and Dick Strid of Delmont will speak on the heritage of Tripp and the surrounding area. The program will also feature local residents taking part in the ALS "ice bucket challenge" and the drawing for a raffle of beef and pork.

Activity shifts from the fairgrounds to Main Street, site of the firemen's dance, Olson said. The firemen traditionally host a street dance, but this year's event incorporates the wagon train and its participants, he said.

"It's going to be a really busy time for the firemen," the mayor said. "They have the street dance on Šaturday night, and then the Tripp and Delmont fire departments are working together for the breakfast on Sunday morning. It's going to be a long day and long night for the firemen."

The Sunday breakfast, held on the fairgrounds, begins at 6:30 a.m. with donations taken for the meal. The cowboy church service, also held on the fairgrounds, begins shortly afterwards so the wagon train participants can hit the road by 8 a.m.

Tripp resident Maurice Bueber will deliver the sermon for the cowboy church service, Olson said. A stage has been prepared for the church service.

As the date nears for the wagon train, Tripp residents are prepared to host the influx of visitors, Olson said.

We have been very fortunate. We have all the great organizations in town, and they are doing a super job with it," he said. "We also have great cooperation between Tripp and Delmont. We are both part of the same school district, and we are working together on this (wagon train).'

The wagon train organizers, who contacted Tripp officials about hosting an overnight stay, have praised the local site, Olson said.

"They toured our community, and they really liked our fairgrounds and other facilities," the mayor said. "If it rains, then we have the ballroom (on the fairgrounds). Otherwise, we can have the activities outside. And we have a lot of areas where (the wagon riders) can take care of their horses. There's plenty of room for that.'

The wagon train isn't new for at least two local men, Olson said. Tripp residents John Finck and Maynard Meyer traveled with the state centennial wagon ride in 1989.

As for the upcoming wagon train, any proceeds from events will go to community projects, including the new downtown park.

But the greatest reward can't be measured in dollars and cents, Olson said. The wagon train shines a spotlight on Tripp in terms of both media coverage and word of mouth from visitors.

"For a small town, this sort of visibility is awesome," he said of the wagon train. "We're sharing with others what we have to offer.
