## Draft Available For Public Review

LINCOLN, Neb. —The proposed Statewide Transporta-tion Improvement Program (STIP) for Fiscal Years 2015 thru 2018 is available for public review and comment at www.transportation.nebraska.gov/STIP/, according to the Nebraska Department of Roads (NDOR). Copies are available from each of the eight district offices.

The Federal Highway Administration (FHWA) and Federal Transit Administration (FTA) require each state high-way agency to develop a STIP. The STIP must list all highway and transit projects that will be using federal funds, as well as all regionally significant transportation projects using non-federal funding sources. It covers a period of four years and in Nebraska is updated every year on Oct. 1.

Federal law requires that all citizens and other interested parties in the state's transportation planning process be given reasonable opportunity to comment on the proposed STIP and on any proposed amendments to an approved STIP. NDOR uses statewide news releases and an automated email subscription management system called GovDelivery to inform the public and advise them of the means and time period to comment on STIPs and any amendments. All comments will be addressed and those responses reported to the FHWA and FTA.

A public comment period ends at 5 p.m. CDT on Sept 1. These comments will be incorporated into the final document which will be posted on the Nebraska Department of Roads' website after approval by the FHWA and FTA.

# **SDHSAA Wades Into A New Era**

PIERRE — Results presented Thursday from a voluntary survey showed Sioux Falls was the top pick for the South Dakota High School Activities Association to hold a state competition.

Sioux Falls received 52 percent of the first-choice votes while Rapid City and Aberdeen got 15 percent apiece. Among students the first choices were Sioux Falls 43 percent, Rapid City 20 and Aberdeen 11

Another question asked whether a state tournament should stay in the same location every year. No was the top answer at 46 percent, followed by no-opinion at 30 percent. Yes came from 23 percent.

There were 5,419 surveys completed. Anyone could participate via the Internet. They identified their roles in a school district: 9.8 percent of the results came from students, while parents comprised the largest group at 41.57 percent.

The survey was conducted by the Lawrence and Schiller marketing company for Dana Dykhouse, the chief exec-

utive officer for the First Premier banking company. The SDHSAA board of directors re-

ceived the report Thursday. The board selects state event sites.

Friction intensified during the past year between the process used by SDHSAA staff and some communities that have hosted state events.

In response the board established a site-selection committee that would have three directors and representatives from the five communities that have hosted most of the state events.

On Thursday the board's president, Rick Weber of Flandreau, chose two new directors, Roger Bordeaux of Todd County and Linda Whitney of Sanborn Central, and himself to serve in the three board slots on the committee.

Weber said he would be the panel's chairman. He said the three present a geographic cross-section of small- and medium-enrollment schools.

The board selected the five community representatives during a previous meeting.

They are school officials Mark Meile of Sioux Falls, Darren Paulson of Rapid City, Gene Brownell of Aberdeen, Terry Rotert

of Huron and Randy Marso of Brandon Valley.

Weber said the panel would meet before Oct. 1. The first round of site locations will be for the 2018-2019 school year.

There was some contentious discussion Wednesday among some of the directors whether they will automatically accept the site-selection committee's report each year or the board will continue to vote on the choices.

Four of the eight directors are new and were serving their first meeting this week. They are Sandy Klatt of Brandon, Steve Morford of Spearfish, Whitney and Bordeaux.

Two more will be new next summer succeeding Weber and Todd Trask of Wall. The two other directors are Jason Uttermark of Aberdeen through June 2017 and Dan Whalen of Pierre through June 2018.

Directors are selected to specific slots for five-year terms by the member schools across South Dakota.

Whitney is filling a vacancy for the rest of a term through June 2016 and Klatt is serving the remainder of a term through June 2018. The terms of Bordeaux and Morford run through June 2019.
