

Iragi Minority Group Set To March

LINCOLN, Neb. (AP) — An Iraqi minority group with strong ties to Lincoln is set to march to the Nebraska Capitol to mark the anniversary of attacks by Islamic State militants.

Organizers say the group will convene at 23rd and O Streets in Lincoln at 10 a.m. on Monday, and will then march to the Capitol and back.

The march will commemorate the Yazidis who suffered and died in last year's massacre in northern Iraq. Lincoln has the largest concentration of Yazidis in the

United States, with many coming to America after serving as translators for U.S. forces during the first Gulf War.

The Yazidis staged a rally outside the governor's residence last year to call attention to the casualties in Iraq and plead for humanitarian assistance.

If the measure reaches the ballot, voters could repeal a law approved by the Legislature in May, when senators overrode Ricketts' veto by the narrowest possible margin. Nebraska was the first traditionally conservative state to abolish the death penalty since North Dakota in 1973.

To prevent the law from going into effect before the 2016 election, Nebraskans for the Death Penalty would have to collect about 115,000 signatures. In either case, the signatures must come from at least 5 percent of the registered

After graduating from YHS, Michael attended South Dakota State University in Brookings, S.D., earning his bachelor of arts degree in journalism in 1993.

Michael's dedication to reporting and writing was, in large part, due to his love of people. And that especially meant family.

He married Carol Lintner on April 16, 1999, in Sioux Falls. S.D. A devoted husband, Michael also loved his family and his in-laws and had a special place in his heart for his nieces and nephews.

Most of his working life was spent as an editor or reporter in the newsrooms of papers of various sizes, from The Huron Plainsman in Huron, S.D., to the Omaha World Herald in Omaha and the Pierre Capital Journal in Pierre, S.D. He also covered the Nebraska Legislature for The Associated Press in 2012.

At the time of his death, Michael was a reporter and editor for the Norfolk Daily News, covering everything from politics and immigration to agriculture and education. At the same time, he
