### Onward Yankton Unveils The Finalists For The Community's Next 'Big Idea'

# The Final Six

Onward Yankton planned to announce its five finalists for the next "Big Idea" and the \$10,000 cash prize.

However, Tuesday's announcement at the Rotary Club meeting featured six finalists because of a tie. The six finalists came from the 508 submissions collected during the 100-day campaign that began last spring.

The tie reflected the intense competition and quality of entries, said State Sen. Bernie Hunhoff and an Onward Yankton committee member.

"This came down to six really good ideas," he said. "Now, the community will help us get from six to one.

The six finalists will give a public presentation later this month, with the Onward Yankton committee selecting the winner in early September, Hunhoff said. The committee will take into consideration the public feedback and online discussion, along with input from the businesses or organizations needed to support a particular

Larry Ness, CEO of First Dakota National Bank and part of the Onward Yankton Committee, noted many of the entries dealt with improving Yankton's

quality of life. 'They're thinking seriously about what we've got to do to make Yankton a better community," he said. "We're a nice little town, but we'll get dust blown in our face if we don't change

the way we do things.' Receiving more than 500 entries was overwhelming, Ness said. He hopes community organizations and individuals will pick up many of the ideas that were good but didn't make

"There are a lot of things we hope happen that aren't even in the top (six)," he said. "We're not saying they're bad ideas - maybe just for another time and place.

Ness hopes the program has stimulated not only thinking and conversation but also action. "If we don't make things happen, we get what we deserve – nothing," he said.

The status quo isn't acceptable, Hunhoff said. "Yankton's doing OK, but OK isn't enough for the future," he said. In particular, Yankton must

attract and retain young people,

### **City Investigation Not Looking At Criminal Charges**

CROFTON, Neb. — An investigation into Crofton city finances isn't looking at criminal

charges at this time, according to a city official. A review team was formed following the dis-

covery of alleged irregularities in the reporting of city operations, said City Manager Charlie Gail Hendrix. The investigative team includes persons with law enforcement and legal backgrounds as well as government and accounting nowledge, she said.

However, that doesn't necessarily mean charges will be filed, Hendrix said.

"Currently, there is not a criminal investiga-

tion," she said. "We just want to make sure the

investigation is handled appropriately."

On Monday night, the Crofton city council passed a number of safeguards in the handling and record keeping of city funds. The policy statements also outlined the separation of responsibilities among various city employees.

The council has made a conscious decision to address policy and not discuss personnel, including former city clerk Nancy Foxhoven who recently retired after 26 years on the job, Hendrix said.

"We decided to focus on policy and not on Nancy or her job performance," Hendrix said.

### Sapa Official **Says Fire Will**

#### **Have Minimal Impact**

Sapa Extrusions officials are saying a fire that forced a 3 ½-hour evacuation of their Yankton operation Monday afternoon will not have a major impact on operations.

Plant manager Kevin Perakslis told the *Press* & Dakotan said he doesn't have a cost estimate on damage, but that the fire was contained to a small

"We have two paint lines," Perakslis said. "The fire only involved one paint line, and in that paint line, there's two paint booths and all the fire was contained to one of the paint booths, which we're very happy about. ... From our first assessment, some of the individuals who have helped have worked through paint line fires before and they're amazed at how limited the destruction was."

Yankton deputy fire chief Larry Nickles told the Press & Dakotan a paint gun is the suspected cause of Monday's fire.

"Right now, we're looking at the possibility of static electricity while a paint gun was being flushed out with solvent," Nickles said.

Perakslis said, after employees were let back in Monday evening, elements of the Sapa plant were incrementally brought back online throughout the night. Everything except for the damaged paint line was up and running normally by Tuesday morning.

Perakslis said the fire will not have any significant impacts on output.

"We have a self-paint line which is our newer, high-performance paint line," he said. "One hundred percent of our customers are painted on that paint line — that's the one that's undamaged. The north paint line, we were only running it a few days a week when we had enough customer demand and we had the manpower. It's not one we plan on running every day. It shouldn't be a major impact on our customers at all.

He added that repairs aren't expected to take

very long.
"We are still checking the structural damage on the roof and it looks like we might need to do some repairs," he said. "But it's all minimal. We can possibly have the paint line repaired and up by the end of this week.'

During the fire, large quantities of firefighting equipment ended up coming into contact with some of the paint used by Sapa.

Nickles said while some pieces are able to be cleaned and salvaged, others will need to be

"The thing we were fearing was our airpacks that are about \$6,500 a piece," he said. "Turns out we were able to salvage everything on those. We did lose about 10 sets of turnout gear (protective clothing) and gloves and about 400 feet of hose. He added that the paint is a safety issue on
