# **Task Force Assigned To Take Next Steps** On Setting Up River-Basins Management

PIERRE - South Dakota's new task force on excess surface water meets this week to begin discussing where the lines should be drawn for nine new natural-resource districts.

The Legislature created the panel as part of calling for districts that would cover each of ne major river basins.

The group also will suggest the alignments for three subdistricts within each one.

The river-basin framework came from the Legislature's previous advisory task force watersheds.

Lawmakers approved the concept earlier this year but in a compromise stripped out all tax authority and regula-tory power, at least for the

time being.
One of the arguments
made by advocates during the legislative debates was that water doesn't observe county lines. That's reflected in the topographic quilt of the nine

Many counties such as Codington, Yankton, Davison, Hughes and Pennington are each in multiple basins, while other counties such as Brown and Lawrence are each in just

The basin configurations are: The Red River and Minnesota River in portions of Brookings, Codington, Day, Deuel, Grant, Marshall and Roberts counties; The Big Sioux River in portions of Brookings, Clark, Clay, Codington, Day, Deuel, Grant, Hamlin, Kingsbury, Lake, Lincoln, Marshall, McCook, Minnehaha, Moody, Roberts, Turner and Union counties; The Vermillion River in portions of Brookings, Clark, Clay, Hamlin, Hutchinson, Kingsbury, Lake, Lincoln, McCook, Miner, Minnehaha, Turner, Union and Yankton counties; The James River in portions of Aurora, Beadle, Bon Homme, Brown, Clark, Davison, Day, Douglas, Edmunds, Faulk, Hand, Hanson, Hutchinson, Hyde, Jerauld, Kingsbury, Marshall, McCook, McPherson, Miner, Potter, Roberts, Sanborn, Spink, Turner and Yankton counties; The Upper Missouri River trench in portions of Campbell, Corson, Dewey, Edmunds, Faulk, Haakon, Hughes, Hyde, McPherson, Potter, Stanley, Sully, Walworth and Ziebach counties; The Lower Missouri River trench in portions of Aurora, Beadle, Bon Homme,

Brule, Buffalo, Charles Mix, Clay, Davison, Douglas, Faulk, Gregory, Haakon, Hand, Hughes, Hutchinson, Hyde, Jackson, Jerauld, Jones, Lyman, Pennington, Potter, Stanley, Sully, Tripp, Union and Yankton counties; The Little Missouri River, Cannonball River, Moreau River and Grand River in portions of Butte, Corson, Dewey, Harding, Meade, Perkins and Ziebach counties; The Belle Fourche and Cheyenne River in portions of Butte, Custer, Fall River, Haakon, Lawrence, Meade, Oglala Lakota, Pennington and Ziebach counties; and The White River and Niobrara River in portions of Bennett, Fall River, Gregory, Jackson, Jones, Lyman, Mellette, Oglala Lakota, Pennington, Todd and

Tripp counties.
The task force's first meeting is Thursday at the Capitol starting at 10 a.m. CT in room 413. It has eight members, including four current legisla-

The state law creating the districts requires the legislative membership have political balance.

The two Republicans are Sen. Arthur Rusch of Vermillion and Rep. John Wiik of Big Stone City, and the two Democrats are Sen. Jason Frerichs of Wilmot and Rep. Steven

McCleerey of Sisseton. Frerichs and McCleerey are from the same legislative district and are farmers and ranchers. Rusch is a retired circuit judge and Wiik is a

parts manager. The four non-legislators are: Paul Casper, a Lake Preston farmer who's been a leading promoter of soybeans; Former state Rep. Kim Vanneman of Ideal, whose family produces wheat; Karl Jensen, a Whitewood rancher active in soil and water conservation; and Denny Kiner, a Davison County commissioner with experience in drainage-board issues.

Frerichs and Vanneman served on the previous watershed advisory group.

The panel has another immediate responsibility this year. That is to help develop a pilot plan for water management on the Red and Minnesota rivers.

In turn the panel is to work next year on recommending guideline to be used by districts in developing their water management

she said. "It amazes me how appreciative they are for what we can do for them, whether it's one month's rent or a utility bill. It's an eye opener."

However, not all ROCS programs are based on income, and not all programs are offered in all 22 counties, she said. Interested persons can gain more information on programs from the ROCS headquarters in Lake Andes or outreach offices in Yankton, Mitchell, Chamberlain and Winner.

ROCS has grown to meet demand over the years. The agency has operated in Charles Mix County since Aug. 13, 1965.

It was founded as Charles Mix County Community Action Program (ČAP) in 1965. In 1966, the name was changed to South Central Community Action Program serving eight counties. In 1981, the agency changed to its current name.

"I remember, when I started working here, that it was 12 counties," Cahoy said. Then, we expanded to 16 and now 22 counties.'

As one of its major pro-

grams, ROCS offers public transportation for both intown and out-of-town needs,

depending on the community.
"We have both buses and vans. People get rides for medical appointments, social outings and jobs," Cahoy said. "A lot of times you can't get all of your medical appointments right there in small towns, so we've scheduled routes (for traveling to regional centers like Yankton). We find that doctors are very good at scheduling (appointments) around public transportation."

Another major program is the Dakota Senior Meals elderly nutrition program for those at least age 60, with a suggested fee for the meal. Guests below age 60 are welcome to the meals for a set fee.

Other programs include: Weatherization assistance for both homeowners and renters, with eligibility based on income. In the case of renters, the landlord must be involved with the process and pay a fee.

For eligible homes, a qualified energy auditor will perform diagnostic testing to determine how to make the house more airtight and energy efficient. In addition, furnaces can be tested to determine if they are working and safe.

• Emergency services to help with things like rent or a utility bill.

• Assistance with school supplies, with eligible households receiving \$20 per child in K-12. The voucher can be taken to a local store to purchase supplies.

 Navigator programs offering assistance offering education and outreach for health care, including the Affordable

• Volunteer Income Tax Assistance (VITA) which helps individuals using the E-Z forms complete their income tax.

• A garden project for low-income individuals and households. This program will provide vegetable seeds, vouchers for equipment and plant sets, and tilling vouchers to income qualified house-

•Referrals to another agency if ROCS can't offer assistance. The number and types of

programs have varied greatly through the years depending on government funding, Cahoy

"Through the 1980s, it was pretty plush. Then, in the 1990s and 2000s, the government funds tightened up and programs aren't out there anymore," she said. "Now, the federal and state governments require a tremendous amount of local matching money that we have to find."

For some programs, ROCs must cover 50 percent of the amount, she said. The agency raises funds through fundraising, set fees and suggested

"One of the biggest challenges is finding local match money," she said. "Everyone is asking for money. A lot of city and county governments have a lot of organizations apply for money (from them)."

The heightened competition for money means becoming more aggressive and turning to more sources, Cahoy said. "We beg from everybody," she said. Still, Cahoy remains opti-

mistic about the future. "We look for more programs all the time and hopefully benefit a lot of people," she said.

The ability to help others continues to offer tremendous satisfaction, Cahoy said.

"It's one of the most fulfill-ing jobs I've ever worked," she
