# **Bypass Petitions** A Huge Success

A petition with over 750 names of supporters were submitted to the Yankton County Commission at their rescheduled meeting Monday, August 10th by Ruth Ann Dickman and Frank Kloucek. The petition signers were from throughout the state and multistate area. The vast majority of signers were from Yankton County, which clearly demonstrated their concern and support for the concept of a bypass. There was no formal action requested by Kloucek or Dickman and no action of any kind, either for or against the bypass proposal. The petition was presented during the open forum section of the meeting. The petition organizers will be encouraging action in the future as the issue starts to come to the forefront.

We were very pleased with the positive comments made by every commissioner and the excellent questions they asked. This is the very early stages of discussion and we will pursue this issue for as long as it takes. The 8 mil-

lion dollar 4th street widening [Hwy 50] and the estimated 22 million dollar total road project cost to the archery complex appears to be a huge waste of taxpayer dollars. A traffic study needs to be done similiar to the one done in 2001. This study, if done correctly, should clearly demonstrate the need for

such a bypass and the justification of local state and national funding for this project," said Kloucek.
