Special Election Set For Opt-Out

A levy intended to pay for road and bridge improvements in Yankton County is set to go to a vote next month.

The special election will occur Sept. 29 in order to comply with the Oct. 1 deadline for setting taxes. Absentee ballots will be available starting Friday.

The levy, passed July 15 and set to take effect in 2016, would impose a property tax levy of 90 cents per \$1,000 of valuation to help aid in funding of road and bridge improve-

ments in the county. Yankton County Auditor Patty Hojem said during the meeting that 677 petition signatures were required to force a vote and the county had received 708. Hojem said the auditor's office has authenticated the signatures.

She did not have a figure available on a cost for the special election.

Commission chairman Todd Woods said there will be a need for drastic changes to the budget should the levy be voted down.

Without this money, we're going to go in and have to change the budget because we're going to have to eliminate road projects and bridge projects in the county because the money is just not there to take care of the roads and the bridges," Woods said. "I'm fearful if it doesn't pass because I don't know what our roads will come to because the money's not there. It's not coming down from the state or the feds.





'Friends' Organize To Keep River Clean

National Parks Service Prepares For Year-Long Centennial Celebration. **RIVER CITY**

With that in mind, a group of river supporters have established the Friends of the Missouri National Recreational River (FOMNRR). The private, non-profit organization will provide opportunities for fundraising and advocacy not currently available for river projects. The MNRR consists of

the 39-mile stretch from Fort Randall Dam at Pickstown to Running Water and the 59-mile stretch from Gavins Point Dam near Yankton to Ponca, Neb.

The public can learn more about the Friends organization during a National Park Service open house from 2:30-7 p.m. Monday at the Riverside Park large picnic shelter. Brief identical presentations will be given at 3 p.m. and 6 p.m. In case of inclement weather, the event will be held at the Dakota Territorial Capitol replica in Riverside Park.

The Friends is an independent organization, but the NPS open house offers a good opportunity to provide more information about the group, said MNRR superintendent Rick Clark.

"We'll roll out formal recognition of the



Friends group, which will coincide with the presentation we're giving about the National Park Service's 100th anniversary," he said.

The NPS has shown interest in the formation of a Friends group for some time, Clark said.

"There have been efforts to formally es-tablish Friends of the MNRR. It's been a high priority with the National Park Service before (my December 2013 arrival in Yankton)," he said. "This will play an important role in river stewardship.

The Friends effort has gained momentum in recent years but has still taken time, said FOMNRR organizing committee chairman Paul Lepisto of Pierre. He also serves as regional conservation coordinator for the Izaak Walton League of America (IWLA).

"Actually, the start of the whole (Friends) process dates back almost two years," he said. "It's been a gradual process to get interested people together about what we want the group to do and what the goals of the

group should be."

The organization has completed incorporation and is awaiting final word on its 501c3 tax-exempt status.

The creation of a formal organization should open the door for more fundraising, said Mary Robb of Yankton.

Robb and Lepisto, along with MNRR Ranger Dugan Smith of Yankton, have provided leadership for four Missouri River events held each May. Those activities include the school festival, river clean-up, river rendezvous and clean boat event.

"It's difficult to raise funds as we are (currently) unable to apply for many of the grants available because the group needs non-profit status," Robb said.

'We've been using other agencies to collect funds for us. With the Friends group, we will not have to rely on another agency. We'll have more funding options available to us.'

When the non-profit status is granted, organizations and individuals can make taxdeductible donations, which should encourage more contributions, Clark said.

However, the Friends organization will benefit in more ways than fundraising, Lepisto

said. "This is going to open up avenues for "he said. donations but also much more," he said. "The goal of the group is to promote and enhance the MNRR for the two reaches of 39 and 59
