Judge Finds Man Spent Enough Prison Time For Birds' Death

LINCOLN, Neb. (AP) — A federal judge has determined a Nebraska man who was imprisoned last year for killing an eagle and a hawk has spent enough time bars and has resentenced him to a year of supervised release.

Lamar Bertucci of Macy originally was sentenced in October to eight months in prison after pleading guilty to shooting the federally protected birds, the Lincoln Journal Star reported.

The 46-year-old and his lawyer objected before his sentencing hearing to a \$10,000 value put on the eagle, arguing it should be lower. They said the figure should be about \$2,000, which is the

value federal courts have traditionally accepted and the value used when Bertucci was convicted of killing another eagle six

A federal probation officer who prepared Bertucci's presentence report had relied on testimony from a Virginia-based wildlife expert to propose the higher amount for the loss of the eagle.

The amount can dictate a sentence length, and the birds' combined value could have put Bertucci in custody for eight to 14 months.

The U.S. 8th Circuit Court of Appeals threw out the original sentence last month. The appeals court determined the wildlife expert's testimony wasn't enough to justify the five-fold increase in the

Bertucci was released pending his resentencing. His lawyer argued that he already spent enough time in custody for a crime that should have carried a maximum sentence of two months.

U.S. District Court Judge Lyle E. Strom agreed Wednesday and gave Bertucci credit for the time he served. But Strom still ordered Bertucci to pay \$2,500 in restitution for the eagle and \$350 for the

If more than one vehicle arrives at the same time, the vehicle on the right goes first."

Tourism Float To Make Rose Bowl Debut

PIERRE - This Saturday, Aug. 15 the Department of Tourism's Rose Parade float will make its initial debut on the streets of Pasadena, Calif. Float builder, Phoenix Decorating Company, will be conducting a first test-run of the float to see how it performs on the street.

"This will be the first time the South Dakota float will see the light of day, and we're very excited to see how it performs and how the public reacts to it," said Jim Hagen, Secretary of the Department of Tourism. "There is still much work to do, but the Phoenix team has done an exceptional job to this point, and we look forward to seeing the finished product.

This first test run is necessary in order to be sure everything is operating properly. Another test run will take place in early September.

'The elements chosen to be featured on the float were based on several factors. First was the theme of the 2016 Rose Parade, which is a salute to the 100th anniversary of the National Park Service," said Hagen. "Elements were also chosen in order to give people an overview of the variety of what South Dakota has to offer. You'll see a nod to our agricultural economy, Native American culture, and some of our iconic wildlife.

The theme of the 2016 Rose Parade is "Find Your Adventure." This theme has grown out of a partnership between the Pasadena Tournament of Roses and the U.S. National Park Service, and will help shine a light on the centennial celebration of our country's national parks.


