Sioux Falls Standoff Ends With Man In Custody

SIOUX FALLS (AP) — A man has been taken into custody following a standoff in central Sioux Falls that forced authorities to close streets and locked down at least one school.

Local media report that the man was taken into custody shortly before 6 p.m. Monday.

The standoff started several hours earlier in the 400 block of North Indiana Avenue near Sixth Street.

Police spokesman Sam Clemens says officers initially responded to a call about a suicidal person that turned into someone being barricaded. The man had been by himself and had a gun.

Students who normally walk home from Whittier Middle School had been kept inside until police said it was OK to release them.

Scholarship Honors Slain Salon Manager

SIOUX FALLS (AP) — A scholarship is being established in memory of a Sioux Falls salon manager who was shot and killed outside the business in September.

Authorities say 24-year-old Amanda Connors was killed while trying to protect an employee from the employee's boyfriend. They say Tyrone Smith killed Connors, then held his girlfriend and her co-workers hostage inside the Cost Cutters Salon for about a half hour before killing himself.

The salon on Monday raised more than \$3,000 in donated haircutting proceeds that will go toward the scholarship fund in Connors' honor at the Stewart School of cosmetology. The salon will match up to \$2,000.

Police Say Bank Robbery Suspect Brags Online

YORK, Neb. (AP) - Authorities say a woman accused of robbing a bank in eastern Nebraska posted a video on YouTube bragging about the robberv.

The York News-Times reports York County Sheriff Dale Radcliff says a copy of the video will be turned in as evidence against Hannah Sabata of Stromsburg. The 19-year-old was arrested on Wednesday in connection with a robbery the day before at the Cornerstone Bank branch in Waco. She faces robbery and theft

The video was posted the same day Sabata was arrested. It shows a woman holding handwritten signs that say she robbed a bank and stole a car. The woman then holds a large bundle of cash in front of the camera.

Omaha Police ID 1 Of 2 Homicide Victims

OMAHA, Neb. (AP) — Omaha police have identified one of the two men found dead inside an auto body business over the weekend.

Police Lt. Darci Tierney said Monday that 47-year-old Carlos Morales was one of the people found dead Sunday afternoon. Tierney says detectives are still working to positively identify the second victim and notify his family.

Police have released few details about the deaths. The bodies of both men were found inside Morales' Genuine Auto Body business.

Neb. Will Defend Driver's License Policy

LINCOLN, Neb. (AP) — Gov. Dave Heineman says Nebraska will vigorously defend a policy that denies driver's licenses to young illegal immigrants, even if the state gets sued by the American Civil

The Republican governor's comments on Monday came days after ACLU Nebraska threatened a lawsuit against the state, similar to one filed against Arizona Gov. Jan Brewer.

In August, Heineman said Nebraska would deny driver's licenses to illegal immigrants who become eligible to work in the U.S.

Heineman says Nebraska wants legal immigrants, but he disagrees with an Obama administration policy that grants temporary work papers to young illegal immigrants. It's aimed at those who were brought into the country as young children.

1 Dead After Car Accident West Of Omaha

OMAHA, Neb. (AP) — Authorities have released the name of a person injured in a fatal car crash west of Omaha.

Police say the crash occurred around 1:15 a.m. Monday on West Dodge Road, near 208th Street. Witnesses told officers that the car had been weaving and speeding through eastbound traffic when it veered across a median into the westbound lanes and rolled.

The name of the person who was killed hasn't been released,

pending notification of family.

The injured person was identified as 19-year-old Colby Burke, of Valley. Burke is being treated at Nebraska Medical Center in

Drought Damage Reaches S.D. Hunting

SIOUX FALLS (AP) — Drought that hurt South Dakota farmers and ranchers this year might also pose a threat to hunting in the

The Argus Leader newspaper reports that drought has cut into pheasant numbers in some areas. It also is cited as a factor for an outbreak of disease in deer that prompted state wildlife officials to pull unsold hunting licenses in several southeastern counties.

Conservation officers say they are still seeing good numbers of pheasant hunters despite fewer birds in some areas. Pheasant hunting is big business in South Dakota, with hunters last year spending \$225 million.

The drought's effect on hunting will be clearer next spring when the Game, Fish and Parks Department releases its annual review of license sales, hunter participation and hunter success

omy in November. The confidence index plummeted into negative territory at 43.5 in November from October's 58.

"Both the fiscal cliff and the uncertainty surrounding health care reform were reported by supply managers as negatively affecting their economic outlook," Goss

The region's employment index inched into positive territory at 50.5 in November, up from October's 47.7. Goss said durable goods manufacturers are hiring at a slow pace but that employment growth is being offset by job losses at nondurable-goods pro-

The prices-paid index, which tracks the cost of raw materials and supplies, improved to 64.4 in November from October's 71.5. But the index still suggests costs are increasing.

The inventory index remained in negative territory at 44.9 in November although it was slightly better than October's 43.5.

"Supply managers have now cut inventories for five straight months. The last time this happened was in 2009 when supply managers were reducing inventories in anticipation of weaker business activity," Goss said.


