The majority of inappropriate behavior in children, adolescents and adults with

developmental disabilities occurs because they are trying to communicate something to us. Individuals who lack an effective way to communicate often exhibit challenging behaviors to communicate wants, needs and emotions, especially frustration. Behavior Analysts and Speech/Language Pathologists work closely together in order to first determine the reason for the behavior, and second, to teach a skill the person can use instead of exhibiting the behavior. When this process all comes together success is two-fold: reduction of inappropriate behavior and a new found ability to commu-

nicate. This workshop, presented by Vicki L. Isler, Ed.D, BCBA-D and Stephanie Sherard, M.A, CCC-SLP with Children's Care Hospital and School in Sioux Falls, is de-

signed specifically for parents and will provide ample time for questions and discussion.

The monthly parent education sessions are free and open to the public and sponsored by South Dakota Parent Connection and the University of South Dakota Sanford School of Medicine Center for Disabilities. The session is appropriate for parents and those working with or supporting children with special needs. Child care is not provided.


# Lincoln **School** Winter **Sing Set**
