Rollo Jack Kreycik, son of Frank W. and Vlasta (Viterna) Kreycik, was brought into this world on June 1, 1939, in Niobrara, Nebraska by Dr. Carl Green. Rollo was born into a good Czech family with the nurturing love of his parents. Seven years after his birth, Rollo was joined by a little brother, Kenard. Rollo spent his early years on the original Kreycik family farm in Western Township, Knox County; three miles straight south of Pischelville. ## **Results Of Homeless** Survey **Revealed**

PIERRE — The 2013 Point in Time Homeless Count revealed that 1,155 individuals are homeless in South Dakota. This number represents a slight reduction from the 2012 count of 1,166 individuals. Forty percent were men, 32 percent were women and 28 percent were children.

While the reduction in the number of homeless counted represents less than a percent, 52 of the 66 counties participated making it the most statewide coverage since the inception of the homeless count in 2001.

The Point in Time Homeless Count was conducted Sept. 24, 2013, by the South Dakota Housing for the Homeless Consortium (SDHHC) in collaboration with community agencies and homeless service providers. The statewide, one-day count was a snap-shot of people experiencing homelessness.

To further define the snapshot of homelessness, 600 count participants were surveyed. Of those surveyed 70 percent were individuals, 20 percent were single parent families, five percent were married couples with no children and five percent were married couples with children. Seventeen percent were veterans.

In 2013, various organizations within South Dakota received over \$2 million from the U.S. Department of Housing and Urban Development to provide funding for housing assistance, operating costs and case management to help reduce those barriers that lead to homelessness.

A few statistics from the 2013 count:

• 139 adults and 17 children were sleeping outside the night of the count; 47 adults and 20 children were sleeping in their vehicles; 243 adults and 153 children were sleeping in an emergency shelter; 186 adults and 103 children were sleeping in a transitional housing program; and 82 adults and 57 children were sleeping in a motel paid for by a non-profit
