

**MMC Holds Inaugural Master Of Science In Nursing Pinning** 

The Mount Marty College's Master of Science in Nursing Program held their very first Pinning Ceremony for December graduating nursing students on Friday, December 13, 2013 at 5:00 p.m. in the college's Marian Auditorium.

The Pinning Ceremony was first established in 1986 for the Bachelor of Science in Nursing program graduates to acknowledge the achievement of the graduating seniors and their transition from student role to their professional role as a registered nurse. In keeping with this tradition the Master of Science in Nursing program will be celebrating the transition of professional registered nurse to the role of Nurse Practitioner.

The nurse's pin represents the philosophy of the school and of the nursing program, and its presentation signifies a sending forth or commissioning of the students to begin their nursing careers as graduates of MMC Tradition defines that the nursing pin is unique to the nursing program from which the student graduates. In the past, a nurse's cap and pin represented the school from which he or she attended. Today, Mount Marty's pin remains as the lone symbol of their education.

We are thrilled to see our first nurse practitioners graduate and become active primary care providers. These students are specialized as pediatric nurse practitioners, adult-geriatric nurse practitioners and family psychiatric mental health nurse practitioners. They will meet the rising health care

The modified Benedictine cross represents a crossroads of ideas and also depicts the ultimate aim of the college: to form persons in the Spirit of Christ with apostolic zeal for the world-wide work of restoring all things for Christ.

# SDHP Reminds Drivers To Travel Safe

The holiday season has arrived and so has the winter weather. During this time of year, highway traffic typically increases as we travel to be with family and loved ones to celebrate. With the increase in travel activity comes an increase in potentially becoming involved in a crash.

December is nationally designated as Drinking and Drugged Driving Awareness Month. The purpose of this designation is to increase the awareness of these dangers, educate the motoring public, and prevent traffic crashes from occurring.

The South Dakota Highway Patrol wants everyone to be safe and to arrive at their destinations safely. The potential of poor weather this time of year can have a major impact on the travel conditions. We all know how unpredictable the weather in South Dakota can be and that the roadway conditions can change rapidly. As these conditions begin to arrive, it is a good time to remember the importance of seatbelt and child seat use. Statistics show that if you are not wearing your seatbelt you will be 21 times more likely to be seriously injured or killed if you are involved in a crash. Obeying the laws and paying attention to what is happening around you can lessen your chance of being involved in a preventable crash.

With the holiday season comes the holiday celebrations. Impaired driving is not an accident, it's a choice. Be the re-sponsible person this holiday season by designating a sober driver as you celebrate. Along with designating a sober driver for yourself, help those around you make the responsible decision. Law enforcement officers are looking to these responsible people to assist in getting the message across and preventing holiday tragedies.

It is important to remember that the decision to drive impaired can not only impact your life but the many others that are also traveling the roadways with you, including your family and friends. During 2011 in South Dakota 34 percent of traffic crash fatalities were alcohol related. This compares to 33 percent in 2010 and 45 percent in 2009. The South Dakota Highway Patrol, along with law enforcement agencies through-out the nation, would like to see this number continue to decrease. In an effort to make this happen, officers will continue their aggressive efforts in removing impaired drivers from the roadway to protect the public.

The South Dakota Highway Patrol will join with law enforcement agencies throughout the State of South Dakota to assist in making this year's holiday season safe and tragedyfree. This goal will be accomplished several ways, including conducting sobriety checks to remove impaired drivers from the road so that they will not put you or your loved ones in danger

Officers across the state will continue to encourage safe driving habits. The patrol reminds drivers to refrain from distractions as you travel. If you need to make a phone call or send a text message, move to the side of the road where it can be done safely. These distractions lead to greater reaction times and an increased risk of a crash. The goal of the South Dakota Highway Patrol isn't to write tickets but to simply educate the public and encourage safe driving habits to keep the citizens and visitors of South Dakota safe.


