Drug Court Grads Hear Words Of Experience

Wednesday's drug court graduates heard from a speaker who understands the trials of addiction.

The Yankton County Drug Court program held a ceremony for three graduates at the Yankton County Courthouse & Safety Center. Together, the graduates completed 1,654 days of sobriety, attended more than 730 support group meetings and payed more than \$10,000 in fines and restitution.

Drug Court is reserved for people who haven't been successful with traditional methods of attempted treatment. The program is a last resort for those facing a felony for a drug-related offense.

The featured speaker was retired judge Mary Dell Cody, who resides in Yankton during the warmer months.

Cody, who served as a Magistrate Judge for the First Judicial Circuit in Yankton for more than 30 years, summed up the struggle of battling addiction.

City,County Put Road Agreements On Hold

An agreement between the City of Yankton and Yankton County regarding shared road maintenance and reconstruction on some roads that cross both jurisdictions is on hold for the time being.

Yankton City Manager Amy Nelson told the *Press & Dakotan* that the hold deals with the county's desire to discuss the plan within a

county committee looking at road and bridge funding in the county. "We were

going to wait to discuss the citycounty road agreeme

county road agreement until the county had a chance to move further along with their newly formed road committee," Nelson said.

The Yankton County Road and Bridge Action Group met for an informational session Wednesday to set ground rules and meeting times. The meeting did not discuss the city-county road agreement and the committee will not address it until at least January, when the group begins regular meetings.

Yankton County Commission chairman Todd Woods told the Press & Dako*tan* that the agreement has already gone before the county for discussion. "Right now, it's a work in progress," Woods said. "It was brought to us last week more as information. He added there's a lot more work to do on the issue. "I hope we can incorporate this into the task force we have coming up that just got formed at the last meeting for a little more direction on it," he said. "There's a lot of work to go forward on it yet.' Nelson said that the City Commission will not address the agreement until the county has had an ample chance to discuss it, but that people will see no lack of services. "I probably won't bring it forward until the county has indicated that they feel that the group's at a place where we're ready to bring that forward," she said. "That being said, nothing's going to change on the maintenance of the roads. It's still getting done, we were just talking about various ways we could split up the responsibilities. I don't think, as far as the city's maintenance, you're going to see

"To turn around addiction, envision turning a battleship around," she said. "That's how hard it is."

Cody noted that the perception of addiction is slowly changing in society.

"I've seen a change in law enforcement," she stated, using Lt. Todd Brandt as an example. "He still has a belief in crime and punishment, but now has a compassionate heart. He sees addiction through different eyes."

Cody touched on her own struggles with alcohol addiction, emphasizing that she understands the struggles addicts go through.

"When you look at an alcoholic, you don't think of illness because people don't have a disease in that way," Cody said. "They think of it in a negative, shaming way.

"I'm not ashamed of being an alcoholic," she added. "I'm not proud of it, but I am proud of my recovery."

She praised Yankton's Drug Court for having an amazing team

Bon Homme Wind Energy Law On Books

TYNDALL – The latest addition to the Bon Homme County zoning ordinance is no longer blowing in the wind.

No referendum petitions were filed by Tuesday's deadline, so the county's new wind farm regulations went into effect Wednesday, according to County Auditor Tammy Brunken. The measure, known as Article 17, was prompted by the construction of the Beethoven wind farm. The farm is located near Tripp and covers parts of Charles Mix, Hutchinson and Bon Homme counties.

Article 17 was further prompted by the proposed Prevailing Wind farms, which would be located at a nearby site in Charles Mix and Bon Homme counties. Article 17 was initially approved by the Bon Homme County zoning board. The proposed law then went to the county commissioners, who held a public hearing in October. The hearing was attended by nearly 100 people who packed the Bon Homme County courtroom.

The commissioners heard about 100 minutes of testimony from 35 people, split between
