Ten-Digit Dialing Begins In 402 Area Code Feb. 26

LINCOLN, Neb. — Beginning February 26, 2011, local phone calls in Nebraska's 402 Area Code must be dialed using the area code plus the local seven-digit phone number. The option to dial local numbers using only seven digits will no longer be available.

Telephone numbers assigned and in service in the 402 Area Code will remain the same. New numbers will continue to be assigned from remaining 402 Area Code numbering resources until the available numbers are depleted at which time new numbers will be assigned from 531 Area Code resources.

In implementing Nebraska's new 531 Area Code everyone placing local and long distance calls, in the geography served by the 402 Area Code, will be required to dial 402 or 531 plus the local seven digit phone number to complete calls. Long distance calls that currently require dialing a 1 prior to the 10digit number will continue to require dialing 1 plus the area code and local number as has been done in the past. The commission warns consumers that dialing 1 plus the local 10-digit number may result in a long distance charge on their landline phone bill.

In addition to changing the way local calls are dialed, all services including automatic dialing equipment or other types of equipment that are programmed with a seven-digit number will need to be reprogrammed to adapt to the new ten digit dialing procedure. Some examples are life safety systems, fax machines, Internet dial-up numbers, alarm and security systems, security

gates, speed dialers, call forward settings, voicemail services, and similar

While some changes are being introduced, the following will not change as a result of the addition of the new 531

· Currently assigned telephone numbers in the 402 Area Code will not

• The price of a call, local and longdistance calling areas, and other rates and services will not change

 Local calls currently dialed with seven digits will remain local calls even though 10-digit dialing is required.

• Placing local calls to communities

included in local calling areas that are outside the 402 area code will also requiring dialing 10 digits (Example: dialing Council Bluffs from Omaha will require adding the 712 area code before the seven-digit local number).

• Three digit numbers such as 211. 511, 711, 811, and 911 will not be impacted by the new 10-digit dialing requirement.

Customers should receive letters from their local telecommunications provider with further details. there," Commissioner Mark Johnson said. "Are we going to request that we utilize only (City of Yankton) water, or are we going to continue to use B-Y Water, which we already have out there? Can we request that we use only city water and not use B-Y Water?

Yankton County State's Attorney Rob Klimisch said that legally B-Y Water has the first option to supply water to the shop because of its location within the rural water district's service boundary. Even if B-Y decides it cannot provide fire protection to the facility, it could still choose to provide domestic water service if it can provide the capacity required for the project. The county would then have to get a separate water line for fire protection from the City of Yankton.

The concern I have is, our mechanical engineer who designed the project has placed in a two-inch service line, Johnson added. "I'm 99 percent sure we only have a one-inch service line currently. We'll probably need to go back to our designer and have him explain why we need this much water

and see if B-Y can supply that to us. If they can't, then we may have to put in a separate service tap or a new one from them." If the county is forced to put

in two lines — one from B-Y for domestic water and one from the City of Yankton for fire protection – Johnson said it would seem "extremely wasteful." "There's not a lot we can do

about it," Jensen said. "The only way is if they cannot service us." Klimisch said he would contact

B-Y's engineering firm this week to determine what water service can be provided for the project. Also Tuesday, the commission: • was told by Yankton County

resident Ann Horton that she believed her mailbox was knocked over by a county snowplow, which resulted in her mail being strewn across the road. She asked that plow operators at least make some attempt to notify residents if such an incident occurs. The commission said it will work to develop a policy for plow operators to follow if a mailbox is struck; • was informed by Sheriff Jim

Vlahakis that cracks are developing in the material used to cover the surface of the Yankton County Jail ceiling. During construction,

the commission expressed concern because cracks developed in the material and the manufacturer worked to fix the situation and reassure the county of the quality of its product. The commission decided to again speak with the manufacturer and try to rectify the situation; and

· was asked for monetary assistance by the Volin Fire Department, which is finding it difficult to raise enough money to purchase the necessary safety equipment for its volunteers. The commission said it would try to find money at the end of the year or work the request into its 2012 budget. In the meantime, the commission agreed to check with other county agencies for equipment they might have no use for that could be utilized by the Volin department.
