### **Anti-Bullying Bill Passes South Dakota House**

PIERRE (AP) — South Dakota school districts without bullying policies would have to adopt one if a bill passed by the House becomes law.

The House approved a measure Tuesday incorporating proposals by Attorney General Marty Jackley and Sen. Dan Lederman. It provides a model bullying policy school districts lacking one would adopt, though they could modify it.

The bill's model prohibits bullying, sets a procedure for reporting and investigating it and addresses "cyber" or electronic harassment.

Its definition of bullying includes a pattern of "repeated" conduct that causes physical hurt or psychological distress. South Dakota has 12 school districts.

Lawmakers voted 57-12 Tuesday, sending it back to the Senate. The Senate's version of the bill lacks the word "repeated" in the definition and wouldn't require the remaining districts to adopt the model.

### Neb. Man Faces 28th Revoked License Charge

FREMONT, Neb. (AP) — Authorities say an Omaha man is in jail after being arrested for driving on a suspended or revoked license for the 28th time.

The Nebraska State Patrol says 28-year-old Rondell Vasser was arrested on Monday after a traffic stop in Fremont.

Vasser, who was also cited for failure to signal and not wearing a seat belt, is being held in the Saunders County jail. His case is not on the online court system, and it's not known if he has an attorney

The patrol says Vasser has 27 prior convictions for suspended or revoked license dating back to 2001.

## **Suspect In Norfolk Shooting Appears In Court**

NORFOLK, Neb. (AP) — A man accused of shooting a woman in Norfolk has waived his preliminary hearing in Madison County Court.

The Norfolk Daily News says 34-year-old Carlos Arevalo-Martinez appeared in court on Tuesday and waived the hearing on charges of first-degree assault and use of a firearm to commit a felony. His case was bound over to district court for arraignment on March 16.

Arevalo-Martinez is accused of shooting 33-year-old Edna Gutierrez on Feb. 14. Gutierrez, who was shot in the head, survived and was hospitalized in Omaha.

Arevalo-Martinez was taken into custody after a standoff with police in Stanton on Feb. 16. He remains in jail on \$1 million bond.

## S.D. House Passes Bill On Missing Children

PIERRE (AP) — A bill criminalizing the failure by a parent, legal guardian or caretaker to report the death or disappearance of a child is a step closer to becoming law.

Under the measure, a person responsible for someone under age 13 must call law enforcement within 48 hours of the child's disappearance and within six hours of the child's death. Someone failing to report on time would face a Class 1 misdemeanor or a Class 5 felony, respectively.

This bill is similar to ones introduced in several states known as "Caylee legislation" after Caylee Anthony, a 2-year-old Florida girl whose 2008 disappearance was not reported for a month.

House members voted 66-4 Tuesday, sending it back to the Senate, which approved a version of the bill that also criminalized health-care providers.

Senate Republican Leader Russell Olson of Wentworth said the Legislature always has balanced the budget, and most lawmakers always have thought the constitution requires a balanced budget.

Voters Will Decide On Budget Amendment

"It is not a clear and explicit requirement for a balanced budget in our constitution," Olson said. "We already hold ourselves to a balanced budget, so we should make it clear in our constitution."

But Sen. Stan Adelstein, R-Rapid City, said he believes the wording of the proposed amendment could lead the Legislature to run up deficits instead of balancing the budget. The measure says spending cannot exceed anticipated revenue, but it does not specify what that means or who would decide how much revenue is expected, he said.

The amendment might wind up encouraging the Legislature to overspend, Adelstein said

"Right now, we have a tighter situation than this amendment would give us," he said.

But Sen. Corey Brown, R-Gettysburg, said the Legislature's Joint Appropriations Committee would continue to be responsible for determining how much state revenue is anticipated for each budget year. That committee's revenue projections have been very accurate in recent years, he said.

Supporters said adding the balanced budget language to the constitution could cause South Dakota to get a better bond rating, which would allow agencies attached to the state to issue bonds at lower interest rates for construction projects, housing loan programs and other purposes.

# **ACLU Of Nebraska To Appeal Immigration Ruling**

LINCOLN, Neb. - Opponents of a Fremont city immigration ordinance promised Tuesday to appeal a federal judge's ruling that kept in place a requirement that potential renters prove their citizenship or legal status.

The American Civil Liberties Union of Nebraska said it would challenge the decision, which struck down another part of the ordinance that would have allowed the city to revoke the rental licenses of illegal immigrants.

The Fremont City Council is expected to meet in closed session Tuesday night to discuss how to proceed with the ruling, which would still allow the city to charge a \$5 fee for a renter's license, if it takes effect. The city has voluntarily suspended the ordinance at ACLU Nebraska's request while the lawsuit works its way through the courts

ACLU Nebraska filed the lawsuit on behalf of five renters in Fremont, a city of 26,000 about 35 miles northwest of Omaha, as well as two landlords and two local employers. The case will go to the U.S. Eighth Circuit Court of Appeals.

Amy Miller, ACLU Nebraska's legal director, told the council in a letter Tuesday that the appeal could last at least another year.

The ordinance stirred a whirlwind of controversy in June 2010 when roughly 57 percent of Frepolls supported it. The measure catapulted the city into the naparisons with Arizona and some immigration regulations.

Fremont has seen its Hispanic population surge in the past two decades, largely due to the jobs available at the Fremont Beef and Hormel plants, which are just outside the city. Census data show the number of Hispanics soared from 165 in 1990 to 1,085 in 2000 and 3,149 in 2010.

It's unknown how many illegal immigrants live in the city. According to census figures, 1,259 noncitizens live there, a figure that includes illegal immigrants as well as lawful permanent residents, foreign students and refugees in the U.S. legally.

## Lawyer For S.D. Bar Owner Accused Of Rape Recused

SIOUX FALLS — The lawyer for a South Dakota bar owner accused of raping a 12-year-old and two 14-year-olds and serving them alcohol was recused Tuesday because he said he had represented a witness in the case.

Third Circuit Judge Jon Erickson said he would appoint a new lawyer for Werner Fajardo, 35, who is accused of assaulting the three girls at the El Cuervo bar in Huron in October.

Fajardo is charged with six counts of rape, four counts of sexual contact with a person under 16 or incapable of consenting, and several counts of providing alcohol to minors. He has pleaded not guilty and is awaiting trial.

Erickson initially appointed Jeff Burns to the case. Burns filed a motion last week asking to be recused, saying he recently discovered that he has represented a witness in the case in the past.

"I believe professional considerations require termination of my representation of the defendant," Burns wrote in the motion.

In a phone interview after the hearing, Jeff Banks, deputy

#### state's attorney for Beadle County, said the change in lawyer would probably affect the start date of Fajardo's trial, which is scheduled for late next month.

Burns also filed several motions on behalf of Fajardo, asking the court for cellphone records between Fajardo and two of the girls from September to December, as well as any criminal or juvenile files of the three girls and any reports from counseling or therapy sessions the girls have taken part in since Oct. 29. The lawyer also asked the court to unseal the search warrant affidavit and sequester the state's witnesses during trial.

Those motions were not discussed in Tuesday's court hearing.

Burns has not responded to a phone message seeking comment.

Police said Fajardo met the girls at "teen nights" at the bar, though patrons were supposed to be at least 18 to attend. Authorities said he pulled off having youngsters in the bar by exploiting an outdated ordinance allowing 18- to 21-year-olds in an establishment serving alcohol if it was designated as a dance hall.






