#### **Mills To Receive Presidential Citizens Medal**

PINE RIDGE (AP) — Pine Ridge native and Olympic gold medalist Billy Mills is preparing to become a medal winner again when he meets with President Obama this week.

The Rapid City Journal reports that Mills, who won a gold medal in track in the 1964 Olympics, will be in Washington, D.C., on Friday to receive the Presidential Citizens Medal. That's the nation's second highest civilian award.

Mills, who now lives in Fair Oaks, Calif., says he is humbled and honored that the president is recognizing him.

Since his Olympic win, Mills, a member of the Oglala Sioux Tribe, co-founded and has become the national spokesman for the Running Strong for American Indian Youth organization, a nonprofit agency that works to strengthen Native American communities.

#### **Neb. Woman Won't Have To Pay Lawsuit Costs**

LINCOLN, Neb. (AP) — A former day care operator won't have to pay the costs for her failed lawsuit against a pathologist who supported charges against the woman related to a baby's death.

The Lincoln Journal Star reports that Lancaster County District Judge Paul Merritt Jr. decided Carla McKinney won't have to pay the legal bills of Dr. Mathias Okoye even though he dismissed her lawsuit. Carla Jean McKinney was charged with the 2007 death of a 4-

month-old baby in her care, based on the autopsy Okoye performed. Charges against McKinney were later dropped after two other pathologists cleared her of wrongdoing, and she sued Okoye and his

corporation for nearly \$275,000. After Okoye won the lawsuit, he asked Merritt to order McKinney to pay his legal bills. Merritt refused.

#### **S.D. Committee To Consider Texting Bill**

PIERRE (AP) — The Senate Transportation Committee is set to weigh a bill that would ban texting while driving across the state— a proposal that has been repeatedly rejected by the South Dakota Legis-

It's one of several bills facing lawmakers this week when the legislative session reconvenes Tuesday.

Now that some cities have imposed their own bans on texting, some lawmakers hope a statewide ban could follow.

The measure would prohibit writing, sending or reading a text message while driving, but it would continue to allow drivers to make cellphone calls and use hands-free electronic devices.

#### **South Dakota GOP Elects Its New Leadership**

SIOUX FALLS (AP) — The South Dakota Republican Party has elected its new leadership team.

Former marketing and advertising executive Craig Lawrence will serve as chairman. He replaces state Sen. Tim Rave.

Gov. Dennis Daugaard's press secretary Tony Venhuizen made the announcement Saturday on his Twitter account.

Venhuizen says former state Rep. Kim Vanneman of Ideal will serve as vice chairwoman, Rapid City attorney Sara Frankenstein will serve as secretary and Pierre attorney Justin Bell will serve as treasurer.

# S.D. Looks To Add More Dairy Cows

SIOUX FALLS — South Dakota is on the lookout for dairy cows.

Gov. Dennis Daugaard and state agriculture officials are traveling this week to the World Ag Expo in Tulare, Calif., with the goal of doubling the state's current herd of about 92,000 dairy

State Agriculture Secretary Walt Bones said South Dakota's herd pales in comparison to California, where a single county might have nearly a half-million cows. The goal, he said, is growth.

"We have a lot of opportunity to grow the business here," Bones said.

A new cheese plant being built in Brookings needs the animals, as do other South Dakota plants aiming to expand dairy operations, said Mary Post, president of the South Dakota Dairy

In June, Chicago-based Bel Brands USA

broke ground on the \$100 million cheese plant in Brookings that will produce the company's wax-wrapped Mini Babybel line of semi-soft snack cheeses. It will employ about 200 people when it becomes fully operational in the summer of 2014, and the workforce could grow to 400 within three years

The Bel Brands plant alone could use 30,000 dairy cows when running at full capacity, Post

Lake Norden Cheese Company, a division of Davisco Foods International, also wants to expand, and Valley Queen Cheese Factory in Milbank could use more milk, Post added.

Post, who owns a 60-cow dairy operation near Volga, said margins have been tight in the dairy industry since the crash of 2009. The following three years have been just OK. He said the feed cost to produce 100 pounds

of milk is about \$11. Additional input costs don't leave much room for profit. "The margins in the dairy industry haven't

been there to justify that expansion, so that's why there's still expansion possible from within before even getting additional permits to produce that milk," Post said.

But everything in agriculture is cyclical, he said, and farmers in other parts of the country feeling pressures are looking to South Dakota, which has plenty of acres and no personal income or corporate taxes.

Bones said most of the growth potential in South Dakota is up and down the Interstate 29 corridor, but there are also opportunities in central South Dakota. State officials try to work with local communities that welcome the business but acknowledge that some simply don't want the business.

"We embrace local control here in South Dakota," he said. "Some don't want livestock development in their communities.

## .awmakers Push Traffic-Safety Measures

LINCOLN, Neb. — Motorists and passengers who ride without a seat belt could face a \$100 fine in Nebraska, and might even see their insurance rates increase if a bill in the Legislature becomes law.

Nebraska lawmakers are peddling a series of traffic safety measures this year that would impose hefty fines on seat belt violators and make it easier for police to stop drivers.

The Legislature's Transportation and Telecommunications Committee will hear three measures Monday that are intended to reduce highway

One bill by Sen. John Harms of Scottsbluff would give police the authority to stop motorists who aren't wearing a seat belt. Current state law treats seat belt violations as a secondary offense, which only allows of-

ficers to cite motorists if they're stopped for some other reason.

The bill would also impose a \$100 fine for seat belt violations, up from the current \$25, and add one point to a driver's record. Accumulating too many points can cause drivers to lose their license or see insurance rates increase.

The fine would apply to drivers and all passengers.

"It's all about safety," Harms said. "If you get seriously injured, and your insurance runs out, then the state may end up taking over the cost. That's one of my big concerns

Harms has also introduced a bill that would make texting while driving a primary offense. Texting while driving is now a secondary offense, but some Nebraska law enforcement agencies have complained that it's difficult to enforce and prove. Lawmakers considered the measure in

2010, but made it a secondary offense after opponents argued that police could use it as an excuse to pull over minorities and young peo-

Sen. Bob Krist of Omaha has introduced a bill that would require all vehicle passengers to wear a seat belt. Krist's measure would also treat seat belt violations as a primary offense. Nebraska law now imposes no seat belt requirements for back-seat passengers.

"It doesn't make a lot of sense," Krist said. "In a crash, whatever is unbuckled in the back seat is going to come forward into the front seat. It just seemed logical to me that everyone in the vehicle should be

The proposals follow an upswing in traffic deaths in 2012, after several years of decline. Nebraska reported 211 people killed last year, up from 181 in 2011, according to the Department of Roads. So far this year, the state has seen 29 traffic deaths.

Craig Bougher, of Papillion, said a crash involving his daughter convinced him Nebraska needs to strengthen its seat belt laws.

Bougher was at home on Dec. 5 when a Sarpy County sheriff's deputy called to tell him a pickup had slammed into his 16-year-old daughter's sports utility vehicle at a rural gravel intersection, about two miles from their home. His daughter, Mackenzie, would be OK, but she was headed to a hospital.

As he hurried to meet her, Craig Bougher drove past the crash scene and saw his daughter's Hummer totaled. The pickup had plowed her SUV into a utility pole. The pickup driver, 30-year-old Zachary Austin, was ejected from the truck. Austin, who died at the scene, was not wearing a seat belt.


