Miller was found guilty on the two counts after a week-long trial.

At the start of Friday's proceedings in Tyndall, defense attorney Scott Podhradsky of Wagner made a motion to set aside the jury verdict.

Podhradsky argued the prosecution provided no evidence that Miller was of "depraved mind." The defense attorney also contended the state did not provide clear evidence on the cause of the infant's fatal injury.

Podhradsky referred to a defense argument that Chris Miller had placed Jacob back in bed, and Stacy Miller had passed out from drinking, rolled on top of their son and accidentally suffocated the infant.

Eng denied the motion to set aside the verdict, based on his observations.

"The court believes the (Parker) jury very seriously took the matter under consideration," the judge said. "The facts do and can support the verdict."

Chris Miller took the stand for proceedings dealing with his alleged probation violation.

The proceedings addressing his alleged habitual offender status focused on February 1993 convictions in Minnehaha County

for aggravated assault of an officer and first-degree burglary, and an August 2009 conviction in Bon Homme County for unauthorized manufacture of a controlled substance.

Friday's court action featured emotional comments and testimony from Chris Miller, Eng and Bon Homme County State's Attorney Lisa Rothschadl. Their voices broke as they spoke.

The parties referred to the wide-ranging impact of the child's death, the public reaction to the crime, and the long two-year court process.

Rothschadl expressed both shock and anger at Chris Miller's continued proclamation of his innocence.

"I am appalled that he's still not taking responsibility for his actions. He continues to blame his wife," Rothschadl said.

"I would hope that, some day, he takes responsibility for the events of March 3, 2011."

The pain of Jacob Miller's death will be felt by those around him long after Chris Miller goes to prison, Rothschadl said.

She said she has received an outpouring of public reaction to Chris Miller's convic-

"During the last two weeks (since the trial), I have received numerous calls, emails and handshakes, even from people who didn't know Jacob Miller, thanking me for doing justice," she said.

As far as the sentencing. Podhradsky said there was little doubt when it came to the second-degree murder conviction. "The writing was on the wall with the mandatory sentence," he said. "The number of years for the other counts don't mean much.'

Podhradsky presented a different picture of Chris Miller, saying his client was misunderstood by the public.

"I believe the community has come up and thanked (Rothschadl)," Podhradsky said. "But (she) has never (had the opportunity to sit) down with the defendant, to get to know him."

As defense attorney, Podhradsky said he has spent the past two years getting to know his client.

(Miller) is not a monster, just a a genuinely good person who makes mistakes," Podhradsky said, "He's not this monster. .. Chris is like a bear. If you get between him and his cubs, he'll rip you apart. But he wouldn't attack his own cub.'

Podhradsky said he has also heard from persons showing sympathy for Miller.

The defense requested the change of venue for the trial because Bon Homme County residents heard only one side of the story or assumed that Miller was guilty because he was under investigation, Podhradsky said.

"Would (members of the public) really think that, if they heard the whole story? he asked.

Miller's 911 call at the time of Jacob's injuries don't match up with someone who had allegedly just harmed his child,

Podhradsky said. Stacy Miller was drunk and could have dropped the child, or the resuscitation efforts could have caused the infant's brain to swell, the defense attorney said.

"People just don't understand (Miller)," Podhradsky said.

Chris Miller said he would continue to proclaim his innocence in his son's death.

"You can let me out (of prison) today, and I won't admit to doing harm to Jacob except for handing him to Stacy," Miller said.

Chris Miller said he was seen as a "bogeyman" because of his prior felonies and the charges against him in his son's death.

Miller requested a return to the Yankton County Jail for the weekend so he could see his daughter one last time before entering the penitentiary.

(Miller) hasn't seen Elizabeth since November. She thinks she has done something wrong, that she hasn't seen her daddv." Podhradsky said.

Miller said he wanted to leave behind a statement of his innocence that his daughter would read someday.

"It's not the pen time so much, it's Elizabeth thinking that I killed Jacob," he said. In his closing remarks, Eng reminded

Miller of his 2009 appearance before the judge "I told you, the court is always con-

cerned when people appear before it. I said, the past dictates the future of people, or they overcome their past," Eng said.

"At the time of your sentence, I asked the number of years you had been in the penitentiary, and you said 14, and you were 35 at the time.'

Eng said he spoke at the time of Miller's circumstances and the direction of his life. The judge said he worried about the impact on Miller if he were sent to prison.

The judge said, at the 2009 hearing, he told Miller that he had worth but had to break free from his criminal past. Miller was a hard worker and appeared to be developing positive relationships, the judge said.

Things seemed to be going well, but Miller then started drinking heavily and complaining that he felt stressed in his life, Eng said.

At Friday's sentencing, Eng said that Miller's choices — including the fatal night at the family's home — had resulted in Jacob's death and tragedy for all those around them.

"Do I think you wanted your baby dead? No. Baby Jacob was very precious to you," the judge told Miller. "But our actions sometimes overwhelm our wants, and what we do on certain days."

With that, Eng passed sentence on Miller and quickly retired to the judge's chambers.

After the proceedings, Miller was transported immediately to the state penitentiary in Sioux Falls.
