

 have also had economic development and jobs increase. We don't do this just for ourselves. We're trying to bring stimulus to our area."
 The new Ohiya Casino and Resort replaces the old facility, which had housed the casino for the past 10 years after being converted from a box factory. Located about seven miles east of Niobrara, Neb., on Nebraska Highway 12 and about two miles east of the previous facility, the new location includes a 25,000-square-foot casino, 47-room lodge with two luxury suites, a banquet facility, restaurant, conference center and a convenience store and gas station. The casino offers 400 Class II gaming machines — double the previous number. Future plans call for an enclosed swimming pool to be added by June and an 18-hole golf course in approximately a year.

With 90 staff members currently employed, the new location has also added roughly 50 jobs to an area with a 75 percent unemployment rate, which was the main purpose of opening the original casino more than 16 years ago.

"We need to think about the generations that are behind us, that they have a secure place to live, an ability to earn money, develop educationally, and to make us a richer people, and to make our region a richer region," Trudell said.
 While construction on the casino building is finished, tribe treasurer Frank Whipple said the work has just begun.
 "With the development of this casino, it increases not only economic opportunities within the area, but it also creates business relationships that will be coming forth and will be developed as the years go by," he said. "The tribe and

I look forward to developing a relationship with the surrounding communities and the surrounding tribes to develop the region to its fullest potential economically."
 The tribe opened the original Ohiya Casino, which featured 29 games and nine employees, in an old cafe in Santee in 1996 after failing for seven years to negotiate with the state for a Class III gaming compact. Weeks after opening, the Justice Department sued the tribe, saying its machines were illegal in Nebraska.
 The tribe replaced the machines with what it classified as Class II games, but the Justice Department deemed those to be illegal as well.
 After facing indictments and daily \$6,000 fines, the tribe fought the government and won in federal district court and the 8th Circuit Court of Appeals. The case eventually reached the U.S. Supreme Court and was dismissed.
 To increase its visibility and provide better access, Santee moved the casino to the intersection of Nebraska Highway 12 and Spur 54D leading to Santee, where it had remained until now.

In June 2011, the Shakopee Mdewakanton Sioux Community (SMSC) of Minnesota awarded a loan of up to \$20 million to the Santee Sioux Nation to build the new Ohiya Casino. The groundbreaking was held October of that year. Thomas said she appreciates everyone who contributed to the ultimate success of the Ohiya Casino, especially those who endured the legal battles along the way.
 "They stood strong," she said. "It was hard, and they moved through to resolve. And if they didn't, we wouldn't be sitting here today."
