Yankton Area Progressive Growth expressed an interest at its recent annual meeting in conducting a housing study for Yankton. Mitchell recently completed such an analysis.

'We thought it might be a good starting point for our community to see if there is really a (housing) shortage, or is it just a perceived shortage?" Mayor Nancy Wenande said Friday during a media briefing. "It will be interesting to see where this comes out."

The possibility of a housing shortage in Yankton was brought up at a previous commission meeting after some commissioners had been contacted by employers about the subject.

On Monday, the City Commission will discuss the creation of a sub-committee that could include representatives from the city, the local housing authority, the Economic Development Council, Yankton Area Progressive Growth, Yankton County, and Planning and Development District III. The group would explore the parameters of the housing study, identify a funding source and possibly look at a plan of action for the community once the document is complete.

In other business, the commission will discuss a proposed sign ordinance and continue debate on the sponsorship/naming rights policy considered at the last meeting.

The meeting gets under way at 7 p.m. Monday in the City of Yankton Meeting Room, located at the Technical Education Center, 1200 W. 21st St.

Social Security Deadline Approaching

BROOKINGS — If you still receive a paper check for your Social Security or other federal benefit payments, you are required by law to switch to an electronic payment option by March 1, 2013. It's fast, free and easy to sign up for direct deposit or the Direct Express® Debit MasterCard®card by calling the U.S. Treasury Electronic Payment Solution Center at (800) 333-1795 Monday-Friday from 7 a.m. to 7 p.m. CST. Wait times are usually minimal. Call now to avoid delays near the

For direct deposit, you can also sign up online at www.GoDirect.org or by visiting your bank or credit union.

CHOOSE YOUR PAYMENT OPTION

Before making the switch, decide which payment option you would like. If you are unsure, you can call the U.S. Treasury Electronic Payment Solution Center at (800) 333-1795 and a friendly agent will discuss options and help you choose the right one for you. The U.S. Department of the Treasury recommends two electronic payment options:

Direct deposit. If you have a checking or savings account, sign up to get your money by directdeposit. Your federal benefit payment will go straight into your account on payment day each month. On time, every

Direct Express® card.If you don't have a bank account or prefer a prepaid debit card, switch to the Direct Express® card. Your money will be posted to the card account on payment day each month. Be careful of anyone who calls, texts or emails you asking for personal information.

Do not give out your Social Security number or account information to anyone unless youare the one who has contacted them.
