those of the federal government, and local cities and counties should have the right to pass their own policies.

The main sponsor of the bill, Rep. Blaine "Chip" Campbell, R-Rapid City, said it's important for states to protect themselves from federal overreach.

The goal of the bill, Campbell said, "is to protect the citizens of South Dakota and their Second Amendment rights."

Brenden Boudreau with the National Association for Gun Rights also testified in support of the bill.

There is a national effort to take guns out of the hands of law-abiding citizens without due process and "anti-gun forces in Washington (D.C.) are working hand-in-hand with the Obama administration," Boudreau said.

He said gun owners can get trapped in a web of local laws policing where they can carry their weapons.

Opponents of the bill strongly objected to a provision that would make felons out of law enforcement personnel who enforce federal laws or local ordinances.

"This bill places our officers in what I think is an impossible situation," said Dick Tieszen of the South Dakota Sheriffs' Association.

Representatives of county and city governments said the bill threatened local authority. Jenna Howell, with the state Department of Public Safety, cited a statement from the Legislative Research Council, which described the bill as unconstitutional and unenforceable.

"There is a supremacy clause issue," Howell said, referring to a provision of the U.S. Constitution that gives federal laws precedence over state laws.

# After New East Storm, Warm-Up In Sight

BOSTON (AP) — A speedy winter storm that blew through parts of the Great Lakes and East on Tuesday is expected to leave a trail of warmer weather and rain that should provide a respite for residents weary of weeks of bitter cold but also create the potential for flooding and collapsing roofs in some areas.

Clogged storm drains could cause ponding and puddles on roads, and in Ohio the National Weather Service said the combination of melting snow and more rain could cause significant flooding. In Michigan, where several roof collapses have been reported since January, there was concern that rain on top of snow could lead to more.

Temperatures above freezing in places where the storm passed through Tuesday should move up to the 40s to mid-50s for the rest of the week, said meteorologist John Cristantello, of the National Weather Service in New York.

Despite the warming and some expected rain on Wednesday and Friday, flooding will not be a concern in New England, said Alan Dunham, a meteorologist with the weather service in Taunton, Mass.

"The snow can handle a lot of rain," he said. "It's not like we're looking at temperatures into the upper 50s and mid-60s. The snow's not going to all melt away all at once. By next week, we'll be back down to normal and below normal temperatures."

The storm took thundersnow to Pittsburgh and areas northeast of the city. Pennsylvania Turnpike officials reduced speed limits along the entire 360-mile highway system but later lifted most of them.

By midday, the weather service said parts of western Pennsylvania had gotten about 6 inches of snow, with 3 inches falling at Philadelphia International Airport and 2 inches outside New York City. The latest storm came days after the Southeast and Northeast were paralyzed with heavy snow, ice and massive power outages.

It was expected to drop 3 to 5 inches of snow on Boston, with 6 to 10 inches forecast for parts of Northern New England, before moving out late Tuesday and early Wednesday. Many schools in Vermont, New Hampshire and Maine canceled classes for the day or sent children home early, and New Hampshire reduced the speed limit on all of its highways to 45 mph.

School cancellations were not an issue in Rhode Island, Connecticut and Massachusetts, where most schools have a February break this week, though the University of Connecticut canceled classes beginning after 2 p.m. at its Storrs and Greater Hartford campuses.

"I'm ready for it to end," said Bill Long, of Abington, Mass., as he waited in line for lunch at a Boston food truck. "It's a pain to come home from work and have to dig out my driveway."

Relief is in sight.

On Monday, several inches of snow fell across the Great Lakes, causing Chicago's two airports to cancel more than 1,000 flights. The National Weather Service said moderating temperatures would result in snow melt and possible flooding in northern Illinois.

In Michigan, crashes closed portions of Interstate 96 in Grand Rapids and the Muskegon area saw whiteout conditions.

Last week, about 1.2 million utility customers lost power as the storm marched from the South through the Northeast. Schools, businesses and government offices closed. The storm was blamed for at least 25 deaths stretching from Texas to Maine.

dents.

"With this ordinance you guys have passed, it cripples our business," said Don Wolf, the parts manager at Fred Haar Co., Inc. "When you get a rotary combine and the engine blows out in the field, you can only tow it so far up to the highway."

He said a combine weighs about 60,000 pounds on its own.

"I can only haul 42,000 pounds legally by your ordinance," Wolf stated. "It stifles (farmers). It stifles me. Progress is stopped."

Mike Schurman, the general manager of Frontier Mills, Inc., said his facility takes loads of more than 80,000 pounds daily.

"(The weight limit is) really going to affect us a lot," he stated.

Ray Epp, chairman of the Volin Township Board, and Dan Schenkel, chairman of the Utica Township Board, said the rule would cost their respective taxpayers more for gravel.

"If the folks that we get to bring in our gravel can't bring full loads, it takes more loads and more money," Epp said.

Added Schenkel, "We're looking at probably a 30 percent increase in the cost of gravel because of this change."

Carmen Schramm, executive director of the Yankton Area Chamber of Commerce, said she heard concerns from grain operators, agribusiness owners, concrete companies and manufacturers.

She admitted she is not sure of the most cost-effective way to save county roads from deterioration.

"But I do know that I represent business, and I have to make sure that we continue to look at (this issue) and not make undue barriers for businesses," Schramm said. "We know it's tough to be in business today."

She offered the Chamber's assistance in the future on matters affecting local business sectors and asked that the weight limit resolution be repealed.

Commissioner Garry Moore spearheaded the effort to craft the resolution, along with Highway Superintendent Brian Gustad.

Moore said he was disappointed that, during the word-of-mouth spread of the weight limit news, few people apparently took the time to read the resolution. It included wording that there would be an option to amend the document if conditions merit such consideration.

"It's easy to sit back and do nothing," Moore told the

dozens of truckers, farmers, implement dealers and other concerned citizens. "We have roads that were built in the 1950s and '60s, and the fact of the matter is ... a lot of them only have two inches of asphalt on them."

Furthermore, he pointed out that some bridges and culverts already have weight restrictions.

"You can't get an 80,000-pound vehicle across them now," Moore said. "What we're doing is trying to preserve the roads we have."

Out of the county's approximately \$12.5 million budget, \$3.6 million goes to the Highway Department.

"The highway budget is much larger than any of the (other departments in the county)," Moore said. "We do what we can with the resources that we have."

"I know one county is grading asphalt off when it breaks out," he continued. "They are not putting asphalt back in. I don't want to see that happening in Yankton County. I want to see us improve our roads so we can get full loads on it."

In "a spirit of cooperation," Moore made a motion to rescind the weight limit resolution.

"We will work on another resolution that will take everybody's concerns into consideration," he said.

The motion received unanimous approval.

"I don't think we foresaw the amount of weights out there over 80,000 pounds. I don't think most of us had an idea of how many people this was going to affect," Commissioner John Harper said. "It was a good intention to save us some maintenance costs on our infrastructure. Hopefully, we can work together and get something more workable in the future."

Jensen said he expects a committee will be assembled to craft a new resolution.

"We're going to need your expertise," he told the audience.

In other business Tuesday, the commission:

- heard annual reports from the Department of Equalization and the Register of Deeds; and

- approved a resolution appointing a limited deputy coroner. Under the agreement, Yankton County and Hutchinson County coroners will cooperate under certain circumstances. In cases where the respective county coroner and the office's deputies are unavailable, or there is a conflict of interest in the investigation of a death, a coroner from the other county can be called in to carry out the necessary duties.
