Seatbelt Fine Stays At \$25, 'Passing-Speed' Gains Approval

PIERRE — The state House of Representatives took two big votes Thursday on rules of South Dakota's roads

House members rejected legislation that would have doubled the fine to \$50 for seatbelt violations.

But they approved letting motorists legally exceed the speed limit at times when passing on two-lane highways.

The "speed to pass" measure now heads to the Senate for It would allow motorists to drive up to 75 miles per hour

when passing another vehicle traveling slower than the speed limit in a 65-mph zone.

"This is a safety concern and a common-sense bill," Rep. Burt Tulson, R-Lake Norden, said. He is prime sponsor of HB

Rep. Tim Rounds, R-Pierre, asked, "How fast was this bill going when it passed Judiciary (Committee)?' 'Ĭt was cruising," Tulson replied.

House members showed minimal interest in increasing the penalty for seatbelt violations.

Rep. Dick Werner, R-Huron, said his goal of increasing the amount to \$50 from \$25 was to "heighten awareness" because South Dakota has one of the lowest rates of usage.

No one spoke up on his side but the opponents came out. "My whole area, I don't think very many of them wear seatbelts," Rep. Dean Schrempp, D-Lantry, said. "I just think we need to get rid of this bill.

Rep. Shawn Bordeaux, D-Mission, said he supports seatbelts and safety but unemployment is high in his area and \$50 would bring "undue hardship.

"I have more children than I can fit in one vehicle with appropriate seatbelts," Bordeaux said.

Werner said there were 130 deaths on South Dakota's roads last year and 72 were the result of not wearing seatbelts and being ejected or partially ejected. Another 500 people were seriously injured, he said.

Rep. Elizabeth May, R-Kyle, said those had to be "a very small percentage of people" who were on South Dakota's

'There can't be a problem with this or we'd be seeing more

Rep. Dan Kaiser, R-Aberdeen, said different fines become a hindrance on law enforcement. Seatbelt violations are a petty offense and the standard penalty is \$25.

"For consistency purposes I would suggest we keep it the same," Kaiser, a policeman, said.

Werner said the state Department of Public Safety, which includes the Highway Patrol, supported the higher fine. Fine money goes to school districts in South Dakota.

We need to be a safer South Dakota," Werner said. Most of the House thought otherwise. The vote was 45-22

Rounds Calls For Arming Ukraine

WASHINGTON (AP) — South Dakota's junior U.S. Senator is joining other lawmakers in urging the president to arm Ukrainians in the fight against Russia-backed separatists.

Fighting between Russia-backed separatists and government forces picked up in January after a month of relative calm. The rebels pledge to carry on with their offensive on the government positions until Kiev stops shelling cities

Rounds says allowing Ukrainians to "punch the bully in the nose" could make Russian President Vladimir Putin "think twice" about aggression.

Mail-In Voting Bill Could Boost Turnout

LINCOLN, Neb — Voting precincts in rural Nebraska could see a jump in turnout if lawmakers pass a bill (LB319) to expand the use of mail-only ballots, Secretary of State John Gale said Thursday

Gale told a legislative committee that counties which use mail-only voting have saved money because they're no longer required to haul special equipment to polling sites to comply with the federal Americans with Disabilities Act. It's also helps turnout in areas with bad roads or bad weather on Election Day, he said.

"It definitely improves the voter turnout because the ranchers and the farmers and small businessmen in those rural precincts are able to cast their ballot by mailing it back," said Gale, a Republican. "It's been very wellreceived by the citizens who are in those precincts.

The bill by Sen. Jim Smith of Papillion would give all counties the chance to conduct elections by mail in certain rural precincts, if the state approves. Under current law, counties can only

seek the state's permission if they have fewer than 10,000 residents.

Smith said his bill is intended for precincts that aren't able to comply with the Americans with Disabilities Act, or that don't have many voters. Counties that already have mail-only precincts have saved time and money,

Some rural counties have switched to mail-in voting in nearly all of their precincts. In Cherry County, state law requires voters to cast ballots by mail in 17 of its 20 precincts. Ballots have to be sent to all registered voters in the 17 mail-only precincts outside of Valentine, so roughly half of the county's voters don't have to request one.

Thomas Ellliott, the county's clerk and elections commissioner, said turnout averaged around 55 percent before the switch to mail-in voting. Now, turnout is closer to 75 percent.

Prior to the switch, Elliott said eight of his precincts were at least an hour's drive from Valentine — and one was 120 miles away.

"For the most part, it's worked well," he said. "Change is hard sometimes, and we had a transition period. But it wasn't the mechanics of going to the all-mail

system. It was getting people accustomed to it."

Some senators on the Government, Military and Veterans Affairs Committee questioned whether the state should pass laws that boost turnout in some areas but not others.

Sen. John Murante of Gretna pointed to a recent legislative election in Cherry County, where voters outside of Valentine differed from those in town and had stronger turnout.

"I'm not sure that's an appropriate public policy for the state Nebraska to have ... but that's the net effect of what happens when you get into those situations," said Murante, the committee chairman.

Sen. Mike Groene of North Platte said he was concerned that an expansion of mail-in voting could lead to fraud, with family members filling out ballots on a voter's behalf or pressuring them to support a certain candidate. Gale said counties work to verify signatures to prevent fraud.

The bill would also let counties use mail-in ballots for special elections involving a candidate, such as a recall or runoff. Current law only allows special elections by mail on financial issues, such as bond referendums.

Committee Rejects Bill To Require Paid Employee Sick Leave In S.D.

PIERRE — A proposal to require South Dakota employers to offer paid sick leave was defeated Thursday, falling victim to business opposition during a legislative

The Senate Commerce and Energy Committee voted to kill the proposal after significant pushback from business groups that argued the state shouldn't add more mandates to burden employers in South Dakota.

The proposal would have allowed employees to accrue an hour of paid sick leave for every 30 hours they work once they've been at the company for three months.

Šen. Angie Buhl O'Donnell, a Democrat from Sioux Falls, said paid sick leave is an important public health issue. She said allowing employees to stay home when they're sick is an especially critical issue now given this year's flu and measles outbreaks.

This is not just a matter

of someone might come to work with the sniffles," she said. "These are illnesses people could die from.'

But new government mandates come with a cost for employers, said South Dakota Retailers Association executive director Shawn Lyons. He told the committee that the proposal would have a "chilling effect" on small employers' ability to stay in business.

Opponents also said the bill was too broad because it didn't cap the amount of sick days employees could earn. They also noted the bill would have applied to all employers, regardless of the business' size.

The bill also was met with concerns about how it might compound the effects of the minimum wage increase that South Dakota voters approved in November.

"Now is not the time to add an additional burden like mandatory paid leave," Lyons

Buhl O'Donnell's proposal came as President Barack

Obama pushed last month for federal earned sick leave legislation and urged states and cities to support similar laws in the meantime. Three states

— California, Connecticut and Massachusetts — require paid employee sick leave, according to the National Conference of State Legislatures.

'South Dakota doesn't have to be last in everything," Buhl O'Donnell told the committee. "When my server doesn't hand me the flu with my steak ... we're all going to be a little bit better off."

But the panel, which included Democrats, voted unanimously to scrap the

Buhl O'Donnell said she hopes lawmakers will start thinking about workers as well as employers.

Republican Sen. Brock Greenfield said he had heard from a significant number of people opposing the measure.

"This issue has garnered the attention of so many people in the private sector, Greenfield said. "I received a lot of concerns.

Senate Approves New Games For Deadwood

PIERRE (AP) — The state Senate has passed a measure that would authorize three new voter-approved games in Deadwood.

The chamber on Thursday voted 27-7 to approve the proposal to allow keno, craps and roulette in the historic mining town. It is now expected to be heard in a House committee.

Supporters have pushed the measure as a way to keep Deadwood competitive with other gambling hotspots such as Colorado and Iowa. In November, 57 percent of voters approved constitutional Amendment

Q, which gave the Legislature the authority to implement the new games.

Senate backers said their colleagues should follow the lead that voters set when they approved the plan. Opponents argue gambling provokes addictions and causes social and financial problems for families in South Dakota.
