

Neb. USDA Seeks Grant Applications

WASHINGTON — USDA Rural Development Nebraska State Director Maxine Moul announced that USDA is soliciting applications for Fiscal Year (FY) 2015 Community Connect Program grants. The program provides grants to establish essential broadband services in rural communities where it is currently not available. "USDA's Community Connect Grant Program ensures that rural residents have the ability to run businesses, get the most from their education, and benefit from the infinite services that fast, reliable broadband provides," said Moul. The minimum amount of grants awarded will be \$100,000; the maximum is \$3,000,000. The deadline for applications to be submitted is Feb. 17, 2015. Last year, USDA announced new rules to better target Community Connect grants to areas where they are needed the most. Energy stocks were among the biggest decliners as the price of oil fell.
