Yankton police arrested a man Monday

Culhane expressed that this is an important way for he and his wife to mix their faith with their love of radio. He also said that their goal is to eventually bring Catholic radio to the entire state.

Culhane acknowledged that, without the community supporting him through the last 17 years, their newest project would not be possible. Because of that, he expresses his gratitude.

I think what we would simply like to say is thank you to the communities that we have served the last 17 years," he said. "We couldn't have done any of this without all of them.

Culhane said that the decision to sell was not easily reached.

"You always sit back and look where you have been, what you have done and where you want to go in your life," Culhane said. "My wife and I sat down and looked at some things, and we decided if an opportunity presented itself (to sell the stations) at this time in our

lives it would be something we would take a look at.

Culhane admits that, through the years, there have been other opportunities, but the timing was just not right.

"It is almost like having a child, you watch it grow up," he said.
"So, yes, it was a difficult decision. The employees that we have had over the years, the clients, our listeners — it has all just been a rewarding 17-plus years. It is always tough to close a chapter of your life and walk away from it. (Closing the sale) was a little bit-

Much like a child, Culhane said the stations have gone through maturation processes.

"We started out in a small building in Vermillion in 1993. Sales were very low at the time," he said. "We watched a metamorphosis take place over the years, with more clients, more revenue being added, the formats changing and then moving to Yankton in 1997-1998. It was a tough decision, but from a business standpoint it was the right decision. A number of our clients were in Yankton, another group wanted to be in Yankton and it really was because we listened to our client base more than any-

thing else that made us decide we needed to be in here."

In August 2002, the two stations were moved into one building in Yankton, a change that Culhane said reflects the changes he has seen in the community itself.

"We progressed when we came here," he said. "The changes I have seen in the Yankton community to move forward are very similar. The community is very proactive."

Culhane detailed the format changes that the stations underwent through the years, all in an effort to help his clients reach the most listeners possible.

He explained that, when they bought the stations, 1570 was a country station and 106.3 was a top 40. During the next several years, the stations would undergo many changes. In May of 2000, they made KVTK sports talk, and in 2007 they settled KVHT into a classic hits format.

"When we moved to all sports on the AM side, we became the first 24-hour 7-day per week ESPN radio affiliate in South Dakota," Culhane said. "For FM, we kind of did a blend of adult contemporary/top 40 and flowed into mix 106 in the late 90s to early 2000 and stayed that way until 2007, when we changed it to a

classic hits format. That format has just been gangbusters for us. It has been a great move and worked out very well for us."

As the stations have grown to become a part of the Yankton community, so too have the Culhanes' relationships within it.

"One of our things we really want to be a part of is to be able to give back to the community that has given back so much to my wife and I," he said. "You do get involved with the different organizations in the community. Local involvement was and is vital for small-market radio. So, that was a real priority for

Culhane said that as the first chapter of their lives in Yankton is closing, it was a pilgrimage to Lourdes, France, that inspired the

"I don't have any regrets," he said. "I don't think that I would do anything differently. We have been very pleased with the outcome of the stations, with their reputations. We are pleased that we sold the stations while they are the top listened-to stations in the market. We went out on top and have no regrets. I wouldn't have changed anything that we did over the


