Neb. Senator Introduces Bills For Veterans

LINCOLN, Neb. (AP) — A Nebraska state senator has introduced bills to help smooth the licensing process for veterans and their spouses if they already have the skill set for a job.

Sen. Amanda McGill of Lincoln submitted legislation Monday that would streamline the process for veterans who need a license to perform a job in Nebraska.

Another bill in her legislative package would ease the process for a military spouse to get a teaching license if they have a license and experience from another state.

McGill also introduced bills that would allow the spouse of a purple heart recipient to keep the specially designated plates if the veteran dies. Her fourth bill would create Nebraska Armed Forces Pride Plates.

Native American Vets Gather For Conference

FLANDREAU (AP) — Suicide rates and post-traumatic stress disorder are just two of the issues that will be addressed at a three-day conference starting Tuesday in South Dakota that is bringing together tribal officials and representatives from veterans' organizations.

About 60 veterans and tribal officials from South Dakota's nine tribes are expected to gather in Flandreau to learn about the best practices to help returning Native American veterans.

Conference coordinator Dennis Quigley says many American Indian veterans fall victim to alcoholism and post-traumatic stress disorder, but many psychologists don't fully grasp Native American culture and the role it plays in recovery.

Quigley says the conference is also a chance to show appreciation for American Indian veterans who have served. A wacipi, or powwow, is scheduled for Wednesday to honor the veterans.

Man Pleads No Contest In Naked Joyride

LINCOLN, Neb. (AP) — A man accused of drunken driving while he and three friends were on a naked joyride near Lincoln last winter has pleaded no contest to a third charge of driving under the influence.

KMTV in Omaha says 33-year-old Nickolus Borgman, of Denton, entered his plea on Monday in Lancaster County District Court. He faces up to 20 years in prison when he's sentenced on March 14.

A deputy investigating a suspicious vehicle stopped Borgman's pickup truck last February. He found four naked joyriders inside the cab and clothes and empty beer cans in the back.

Borgman was arrested. The others weren't cited.

Lethal-Injection Drug Buy Defended

LINCOLN, Neb. — Nebraska Attorney General Jon Bruning produced documents Monday that he said contradicted claims that state offi-

cials had been conned into buying stolen doses of an execution drug. The Nebraska Department of Correctional

Services announced in November that it had obtained sodium thiopental, one of three drugs needed to carry out executions by lethal injection, from Swiss company Naari AG. The drug is no longer manufactured in the United States and is in scarce supply worldwide.

The state plans to use the drug to execute Michael Ryan for a 1985 slaying. But Ryan's attorney claims the doses Nebraska recently bought were supposed to be used only for "test and evaluation" as an anesthetic in Zambia and

Bruning said the documents, the emails and financial statements released Monday show the Indian drug broker, Harris Pharma LLP, bought the drug from Swiss manufacturer Naari and

then sold doses to Nebraska.

Naari's chief executive Prithi Kochhar previously sent Bruning a letter saying the doses were free samples provided for tests in Zambia and "wrongfully diverted." Kochhar said Naari would never support use of the drug in execu-

Ryan's lawyer, Jerry Soucie, declined to comment Monday, saying he had not yet seen the attorney general's court filing that included the documents. Soucie has previously said Bruning advised the corrections department on how to

acquire the drug.
Bruning said Monday that Kochhar's claims that Nebraska's purchase was illegal were baseless, and he accused Soucie of creating a "circus sideshow.'

"Naari clearly knew, based on the emails . . . that this drug was being sold to Chris Harris," Bruning said.

He added, "I think it's outrageous that the conversation continues to be about the method of execution as opposed to the brutal murders committed by Michael Ryan and Carey Dean Moore," another death-row inmate.

Ryan was sentenced to death for torturing and killing James Thimm at a farm near Rulo in 1985. Moore was convicted of murder for killing cab drivers Maynard Helgeland and Reuel Eugene Van Ness in 1979.

Bruning has a pending request before the Nebraska Supreme Court to set an execution

date for Ryan. Nebraska's \$5,411 purchase of sodium thiopental marked the second time it has gone to India to obtain the drug.

In January 2011, the Correctional Services Department announced it had obtained 500 grams of sodium thiopental from an Indian company, clearing the way for Nebraska's first execution by lethal injection. But questions soon arose about the legality of the purchase by Nebraska and other states, and the U.S. Drug Enforcement Agency seized stockpiles of the drug from several states, including Georgia, Alabama, Kentucky, South Carolina and Tennessee.

The DEA declined to say then whether Nebraska's purchase was under investigation, but state officials sought a new supplier anyway.

S.D. Medicaid System Update Behind Schedule

PIERRE — Development of a new computerized Medicaid management system is far behind schedule because of a dispute between the state and the company hired to do the work, a South Dakota official said Monday.

The state signed a contract in 2008 with Client Network Service Inc. of Maryland to develop a new \$72 million computerized system for managing the program that pays medical expenses for low-income people. But the state terminated the contract in October 2010 because the work was behind schedule and of poor quality, state

Social Services Secretary Kim Malsam-Rysdon told a legislative committee.

The company then sued the state, which in turn filed a counterclaim in state court.

However, the federal Centers for Medicare and Medicaid persuaded the state and Client Network Service to enter mediation in an attempt to resolve the dispute and get the project moving again, Malsam-Rysdon said.

She told the Legislature's Government Operations and Audit Committee that she hopes to get a response from the company by the end of January as a result of the

Malsam-Rysdon said the media-

tion process might solve the dispute and get the project moving again. She said the state and the company agreed not to disclose information from the mediation

The project was supposed to be completed by July 2010, but only some parts of the data management system are up and running, Malsam-Rysdon said.

Websites that provide information to the public and health care providers are working well, but key parts for handling claims are not complete, Malsam-Rysdon said.

The federal government is to pay 90 percent of the cost of the new computerized management system, which will replace a system that is about three decades old. The federal government is requiring all states to update their computer management programs for Medicaid.

When lawmakers asked whether the state might have to hire another company to finish the project, Malsam-Rysdon said: "I guess I don't want to rule out any options.'

Members of the legislative panel urged Malsam-Rysdon to make sure the project gets done right.

Because we've got taxpayers' dollars involved, we need to make sure we're getting a valid product for the money we're spending," Sen. Jeff Haverly, R-Rapid City, said.
