

It is unlawful for any person or premises without a license for the sale of alcoholic beverages, which is to include a license authorized to sell low-point beer, while in the presence of any other person: a) To fail to conceal, with a fully

opaque covering, the sexual parts of his or her body, to include the genitals, pubic area, and anus of any person, or the nipple and areola of the female breast. b) To expose any device, costume or covering which gives the appearance of, or stimulates, the

genitals of pubic area of the male or female body, or the nipple or areola of the female breast. SECTION 2: Shows such as male strippers, female strippers, topless or bottom-

less waitresses, erotic performers, or similar type shows shall be considered by the Town Board to be a violation of this Ordinance. SECTION 3: Any person or premises without a license to sell alcoholic beverages

in violation of this Ordinance, shall be fined in a sum not exceeding Two Hundred Dollars (\$200.00) or be imprisoned not exceeding thirty (30) days or punished by both such fine and imprisonment. SECTION 4:
