he said.

"In every field, people want to strive for something better," Daugaard stated. "They want to be able to achieve more through their hard work. Many of our teachers go the extra mile, but most of them are still paid based on seniority and academic credentials. We need to reward them for their service to our young people through this investment program.

"I don't promise that this is the answer," he continued. "I don't promise that it will succeed. I do observe that the current system isn't working, regardless of the fact that we've invested quite a bit more money into it. Simply putting more money into it hasn't worked. I believe a more targeted approach designed to target the single factor in school that research shows makes the difference, investing in great teachers, I think has a good shot at moving our achievement bar."

Some studies have shown that merit pay systems have not improved test scores implemented at schools elsewhere, but Daugaard doesn't believe those programs were as widespread and all-encompassing as his plan.

On the workforce initiative front, Daugaard wants to better prepare youth for the workforce, provide job training opportunities for skilled workers, promote rural health occupations and recruit new workers to South Dakota.

Projections have shown that there will be 41,000 new jobs created in South Dakota between 2008 and 2018. Meanwhile, the state's available job force is expected to

Still, he said the department has to improve its efforts to become more preventative.

"At this point, we're in a reactive mode, and we have to switch that over and become proactive," Paulsen said. "As we see our stats and start looking at them, we can introduce some information on synthetics or narcotics that are showing up. We'll start pushing that information out to Coalition for a Drug-Free Yankton, the schools and others. We'll start searching for resources to help us remedy this before we see more cases."

Of particular concern is the proliferation of synthetic marijuana use, he stated. Federal authorities had banned synthetic marijuana, but manufacturers have been able to change the chemical compounds enough to bypass the prohibition. Products containing synthetic marijuana can be bought legally at smoke shops and gas stations.

According to the University of Michigan study, one in every nine high school seniors reported using synthetic marijuana in the prior 12 months.

shrink. Many of those jobs will be for engineers, accountants, IT professionals, welders, machinists and health care professionals.

While Daugaard said the majority of his focus is on preparing current South Dakotans for the jobs available, the truth is that the state needs to recruit new residents.

"We need people out of that pipeline today, because we've got more job openings than we have skilled workers," he said. "In the near term, we're going to have to recruit from other places. When there is high unemployment in some other places, now is the time to strike."

Part of the effort will be to reinvigorate the Dakota Roots program, which seeks to attract former South Dakotans back to the state.

Another prong will be to work with Manpower, Inc., to recruit workers for certain positions.

"We're going to make sure we don't have South Dakota skilled workers (before we ask Manpower for help)," Daugaard said. "South Dakotans will have a 30-day first shot. Those jobs must be posted on our job site for 30 days, and if no South Dakotan applies and gets accepted, we turn it over to Manpower, Inc."

One of the businesses that has expressed interest in taking part in the program, if the Legislature approves it, is Applied Engineering of Yankton, the governor said.

The recruit will have to stay for at least 90 days, or Manpower will have to replace the individual for free. For some professions, it will be 120 days.

"We will partner with businesses that want to invest money in recruitment and will help invest money in recruitment," Daugaard said. "Manpower only gets paid if they are successful."

"We're not modifying our efforts fast enough to address the synthetic marijuana," Paulsen admitted. "Part of our approach has to be education. These kids have no idea what the consequences of using a synthetic is."

Synthetic marijuana can cause adverse reactions, and several Yankton teens have needed psychiatric care after using it, he confirmed.

Authorities cannot be successful in curbing the use of alcohol and drugs without parents, Paulsen said.


"It's that whole triad that has to work together: parents, the schools and law enforcement," he stated. "All three of them have to communicate and be responsive to one another. I think if we can continue to strengthen that relationship, it will be helpful. Hopefully, we can stop the influx of drugs, make kids aware of the effects and deter them from using them."

If parents suspect something is wrong with their children, they need to take some action.

"You have to trust your gut and do some investigating on your own," he said. "It doesn't necessarily have to involve the courts or an arrest, but if you find a drug we can help dispose of it, as well as steer you toward the resources we know of to assist you in righting the ship."
